Last June the Chignecto-Central Regional School Board laid off 65 Educational Assistants, then rehired 23 in September. On October 2, the board posted and additional 38 Educational Assistant positions on the CCRSB website. The 42 EAs on lay off are being offered first opportunity to accept the 38 posted EA positions. Noel Hurley, Superintendent of Schools says, "There's a misconception in the community that we have cut services for students with special needs"

That's just not the case," says Hurley. "The Board has, in fact, increased service hours for students with special needs from 1905 hours per day last year, to 1910 hours per day this year, even though student enrollment declined by over 800 students. CCRSB is comprised of 17 Board members and over 3000 staff striving to provide a well-rounded education for approximately 23,000 students throughout Colchester, Cumberland, East Hants and Pictou counties.



The Chebucto Symphony Orchestra is joined by awardwinning cellist Maia Bruce on Saturday, November 14th at 7 p.m. at St. Andrew's United Church, King Street, in Truro. The 17-yearold rising star will play Dvorák's Cello Concerto in B Minor. The orchestra will also perform Schubert's "Unfinished" Symphony and "Autumn" from Vivaldi's The Four Seasons. Advocate Harbour to get seawall repairs. Federal Fisheries& Oceans Minister, Hon Gail Shea, who toured the area last week, assured local residents she will find the emergency funding to deal with the matter immediately by having rocks placed across the damaged seawall before the onset of winter. A portion of the community is below sea level and residents are fearful another storm could cause irreparable damage to the community. Many have been calling for the construction of a breakwater to protect the existing seawall and the community. Members of the community estimate emergency seawall repairs will cost upwards of \$1-million.

Remembering Lt. Col. George Isaac Smith, MBE, E.D., D.C.L., LL.D, LL.B.

November 7, 2009, will see the opening of an exhibit at Colchester Historical Society Museum entitled "Life and Times of G. I. Smith". G. I. was the MLA for Colchester County from 1949 - 1974, and Premier of the Province of

Nova Scotia from 1967 -1970. The exhibit will highlight the life, contributions and accomplishments of G. I. Smith against the backdrop of the political, military, legal and social climate of his time.

The year 2009 marks the one hundredth anniversary of the birth of George Isaac

Smith in Stewiacke. The Smith family and the G.I. Smith Memorial Trust feel this to be a natural time to celebrate the achievements and contributions of "Ike", as he was known by family and friends, while at the same time fostering understanding of the importance of dedicated

political and government service. Ike, and his wife Sally, believed it was vital to the

success of our province, that able, dedicated people commit to public and political service. They both saw



public life and service as a high calling.


A truly remarkable cast of Colchester men and women has served as MLAs over the past 160 years. It is important to remember these people and the values for which they stood. It is hoped this exhibit will help to ensure that a legacy of integrity, ability and innovation in public service will continue to thrive.

Ike performed with distinction in three different important fields of endeavour; the practice of law, military service and public life.

In 1936, he and the late Frank Patterson, Q. C., formed the Truro Law firm Patterson and Smith - now known as Patterson Law.

In 1939, just before the outbreak of hostilities, he went on active service with the North Nova Scotia Highlanders. He remained in active service until six months after World War Two. By the end of the war he had achieved the rank of Lieutenant Colonel, had been awarded an MBE (Member of the Order of the British Empire), was mentioned in dispatches and was honoured by the Dutch Government

Local Torch Bearers Thrilled Once in Lifetime Opportunity Olympic Winter Games.

The 2010 Olympic Torch Relay began its journey to Vancouver with a traditional lighting ceremony in Olympia, Greece on Oct. 22nd, 2009. The Olympic Flame will then travel 45,000 kilometers across Canada, passing through province and territory.

Twelve thousand Canadians will be given the opportunity to carry the Olympic Flame, with more than 1000 communities involved. This will be the longest Olympic Torch Relay in a single country.

The Canadian torch jour-

ney begins in Victoria on Oct. 30, 2009. The relay will come to an end at BC Place on February 12, 2010, with the lighting of the Olympic Cauldron, signaling the start of the Vancouver 2010

Truro is a celebration community for the route and a gathering is being planned for 7PM, on November 17th, at Victoria Park. Bob Piers will carry the torch the last 300 meters into the park.

At least two other members of our local community will be involved in the excitement of the Olympic Torch Relay.

Cara Murray, of Masstown, will be carrying the flame for 300 meters along Route 2 in Elmsdale. Ralph Bastarache, of Lower Onslow, will have his opportunity to share in this part of history as he carries the torch along North Provost St. in downtown New Glasgow.

Cara was encouraged to enter an online Olympic Torch Relay contest by her son Matthew early last spring. "There were different categories for the applications,
