RRFB Nova Scotia is now accepting nominations for the 2011 Mobius Environmental Awards. Currently in their 13th year, these awards recognize the achievements of innovative individuals and organizations that help Nova Scotia move closer to achieving its waste disposal goal of 300kg/person/year by 2015. The deadline for nominations is April 22nd, 2011. The Mobius Awards luncheon will be held on Tuesday, June 7th, from 12 noon to 2 p.m. at Pier 21, 1055 Marginal Road, Halifax. Physicians in Nova Scotia will be saving the province an estimated \$45 million over the next two years by reducing their increase from 4% to 1%. Even though 82 per cent of doctors supported the proposed amendments, many voiced concerns over government's intent to retract funding already committed to in a signed contract. The amended contract will come into effect on April 1, 2011 and expire on March 31, 2015. The original contract would have expired on March 31, 2013.

Women entrepreneurs in Atlantic Canada will have increased opportunity to reach new export markets and do business with Fortune 500 companies, thanks to a certification program for women-owned businesses. WEConnect Canada will manage the delivery of the certification program for women-owned businesses in Atlantic Canada and provide mentoring and coaching for certified businesses. ACOA is providing a contribution of over \$134,000 toward the project, through its Business Development Program (BDP); WEConnect is investing an additional \$152,000.

## RFQ: Tidal Energy Device Collector Circuits

Fundy Ocean Research Center for Energy (FORCE), which is developing the tidal power demonstration and testing site at West Bay has issued a request for quotations (RFO) from firms to provide civil and electrical contractor services. The RFQ stipulates items such as: including

materials supply, to develop the infrastructure required for the interconnection of power, control and SCADA cables between the FORCE substa-

tion control building and the shore end of four composite, submarine cables; one for each tidal device.

This portion of the work will provide the infrastructure to enable the transfer of tidal generated power from the shore interconnection to the electrical substation: a small but critical stretch onshore from the end submarine cable end to the transmission grid.

The work includes the installation of concrete cable vaults, insulated power cable, optical fibre cables, as well as the supply and installation of significant systems including drainage, concrete encased du ct banks, electrical grounding and bonding, cable trays and supports, junction boxes, and many other electrical systems.

A lot of work has been done onsite. Construction of the substation control building and Interpretive Centre is nearing completion. An opening is scheduled later this year.

## **Fourth Berth Awarded for** Tidal Power Testing

Atlantis Resources Corporation, a world-leading tidal technology and project development company will test one of the world's largest tidal turbines in the Bay of Fundy's aggressive marine environment. Atlantis was one of five respondents to a request for proposal issued by the province last fall for a fourth berth-holder to participate in its Fundy Ocean Research Center for

Energy (FORCE) project.
The company will work in partnership with Lockheed and Martin Irving Shipbuilding to customize, build, deploy and monitor their one megawatt AK-1000 Mark II turbine at FORCE's Minas Passage test site. The project will involve more than fifty per cent local content. Lockheed Martin, which has 130 full time employees in Nova Scotia,

be responsible for engineering design elements, production drawings and procurement of major turbine components along with systems testing.

Irving Shipbuilding, with more than 1200 shipyard workers in the province, will oversee construction of the turbine base and assembly of the device in conjunction with other local suppliers. Deployment of the Atlantis

turbine is planned for summer 2012.

Atlantis joins three existing berth-holders in the FORCE project: Nova Scotia Power, in partnership with Open Hydro of Ireland; Minas Basin Pulp and Power, working with Marine Current Turbines technology; and Alstom of France using their Clean Current technology.

FORCE is scheduled to install four subsea transmission cables to connect the test turbines to the electrical grid in the summer, giving Nova Scotia the largest instream tidal power capacity in the world.

## We vote May 2nd
