

## Leefe's Joint Council's Report of February 18<sup>TH</sup>

In his report to Cumberland and Parrsboro Council's for the period up to February 18th, Transition Coordinator, John Leefe reported Paul Wills completed the DAMs for Parrsboro and Parrsboro/Cumberland combined. This piece was forwarded immediately to Parrsboro, Cumberland and Kim Livingston at Grant Thornton for review. It is anticipated Grant Thornton will complete their work and report on February 12. This provides sufficient time for review of the report and filing with the NSUARB by Peter Rogers on February 19.

On January 26 the NSUARB forwarded 12 Information Requests to Peter Rogers QC. He has forwarded them to the Transition Manager who is creating draft responses. The Manager has notified specific Parrsboro/Cumberland staff, who have the expertise to provide the critical technical information. Their responses were required by February 3. The end of the week included a check in with Pat Hartling, who is making progress with individual Parrsboro staff interviews and preparing an effective transition plan for a combined Parrsboro and Cumberland organization.

The week of February 1st focused on making final edits to the 26 IRs (Information Requests) emanating from the NSUARB. The finished document was vetted by Peter Rogers QC and filed with the Board on February 12. On a parallel stream, Kim Livingston CA, Grant Thornton received the

reworked Debt Affordability Models which she and colleagues will review with respect to efficacy and is confident they will be ready for pre-filing review early in the week of the 15th with URB filing on the 19th.

During the week of February 8th, a comparison of all dissolutions and mergers completed in 2015 and underway in 2016 respecting Letters of Intent. No two are alike as all are derived from circumstances unique to each unit. The Transition Manager produced a most useful table that allows the reader to compare "apples to apples". The responses to NSUARB's Information Requests were filed by Peter Rogers QC on schedule on February 12. Kim Livingston continued to make good progress on the DAMs review.

The week of February 15th comprised the Transition Coordinator and Transition Manager finalizing the agenda for the NSUARB pre-hearing meeting with Peter Rogers

QC. Participating were Rennie Bugley CAO, Ray Hickey CAO, Andrew MacDonald, Director of Finance Cumberland, the Co-ordinator and Manager. The purpose of the meeting was to identify potential witnesses for the schedule URB hearings on March 30-31. Those selected will be briefed by Mr. Rogers.

On the same day, representatives from the units, the Transition Co-ordinator and Manager met with Deputy Minister Municipal Affairs Dan McDougal and senior departmental staff to review the Letter of Intent "ask" should dissolution and merger be approved by the URB.

The Co-ordinator and Manager reviewed the agendas for the Transition Committee meeting of February 18 and for the Joint Council meeting of the same date. The Manager will focus on the financials that have been created by the Transition Team and independently verified by Kim Livingston CA of the firm Grant Thornton.


