At the E.D. Fullerton building in Upper Nappan, a lobby limit of two people at a time will be enforced. The Upper Nappan Service Centre will be open Monday through Friday, 8:30 a.m. to 4:30 p.m.

At the Dr. Carson and Marion Murray Community Centre in Springhill, a lobby limit of four people at a time will be enforced. The Springhill Service Centre will be open Tuesdays and Thursdays only, 10 a.m. to noon and 1 p.m. to 3 p.m. The opening of the Service Centre function in Springhill does not include the entirety of the community centre such as public meeting spaces, recreational

activities, the Ross Anderson PharaChoice Teen Centre, the CIBC Room or the indoor walking track.

The Service Centre in Parrsboro will be relocated to 209 Main Street (the former CIBC building). A lobby limit of four people at a time will be enforced in Parrsboro. The Parrsboro Service Centre will be open Monday through Friday, 8:30 a.m. to 4:30 p.m.

Residents wishing to make a payment are still empowered to use the alternative payment methods including drop boxes, mailing cheques, electronic payments through a financial institution, preauthorized payment or credit card through Paymentus.

Residents who need to meet with staff are encouraged to make an appointment prior to arrival as staff offices are unavailable for meetings with the public.

He has played with symphony orchestras in Canada and Germany, and col-

laborated live and on recording with U.S. guitarist Andy McKee, Canadian singer/guitarist Brooke Miller, Canadian guitarist Calum Graham, & Toronto bassist Jordan O'Connor. He also composes scores for television, radio, and film, and does production and recording engineering for a variety of other musicians. In addition to acoustic guitar, Don also plays electric guitar, slide dobro and lapsteel guitar, harp guitar, voice, piano, keyboards, bass guitar, and drums. He has just started learning to play the Kelstone, a 9-string guitar developed by Belgian musician/inventor Jan Van Kelst.

Don Ross grew up in Montreal, has lived at various times in Ontario, Nova Scotia, the USA, China, and Quebec, and now resides in Halifax.


Council meeting on July 8th began at 5 pm in camera/zoom with 4 items covered. At 6 pm we began public council with a moment of silence for Bob Arsenault a long time employee who recently passed away.

Next item discussed was a organizational review to look at where we are and where we are going post dissolution of Springhill and Parrsboro. A report will be issued this fall. A motion to submit three FOIPOP applications to the province was approved by motion. A motion to ask the UARB to look at the orders given with the dissolutions was also approved. We wish to ensure that citizens are getting what was promised.

A motion to approve a letter to the province regarding the APA decision regarding chapter 11 and an amendment was approved. These are all ongoing.

First reading on amendment to land use bylaw to rezone a property on north shore road Wallace was approved by motion. Notice to give notice to all councillors that an ice allocation policy will be considered for adoption at the July 22 council meeting was approved. A tax remittance to adjust the 2019 commercial tax levy was approved by motion.

as well as a grant from the Pugwash Harbourfest committee was approved by motion. A provisional grant request for the Amherst little league was also approved.

The grant approved for the Oxford arena was approved to be put back into the regional grant pot as the arena will remain closed this year. A motion to pay the 2nd quarterly installment to the YMCA was approved.

A motion to appoint the warden and CAO to sit on a committee with the other municipalities involved in the April tragedy to identify a permanent memorial was approved by motion. A discussion and motion to open the Glooscap Campground to transit travelers was also approved by motion and a motion to bypass our hir-

ing policy in order to get extra staff at the campground was also approved.

A one-time change due to the current covid climate! Information item included a statement from Warden Gillis that he would not be reoffering this fall as councillor for the Pugwash area and would not be running for the new mayor position. Thank you Al for your 12 years of service to the municipality of Cumberland and as you stated thank you staff. It was a pleasure to be on council with you!
