Hospital Construction to Start

Pugwash will soon be home to a new, modern health-care facility, with construction about to begin on the North Cumberland Memorial Hospital, representing an investment of \$25 million. North Cumberland Memorial Hospital opened in 1966 and serves the communities of Pugwash, Wallace, Malagash, Port Howe and surrounding areas.

Lloyd Hines, Minister of Transportation and Active Transit, on behalf of Health and Wellness Minister Zach Churchill, was joined today, July 12, by hospital staff and community members to break ground on the site announcing construction will start in July on the new North Cumberland Memorial Hospital.

Transportation and Active Transit Minister Lloyd Hines, on behalf of Zach Churchill, Minister Health and Wellness, turned the ground breaking sod for the new North Cumberland Memorial Hospital on Monday, July 12, at 12 p.m.

The event took place at 260 Gulf Shore Rd., Pugwash.

Environmental Liaison Committee Northern Pulp

An independent, community-based Environmental Liaison Committee (the "ELC") is comprised of individuals from the local forestry, fishery, labour, environmental science, and business communities who are working to better understand stakeholder issues and concerns with respect to Northern Pulp's historical operations and proposed Mill restart plan.

The ELC's objective is to encourage that any transformation of the Mill be done in accordance with a manner that respects the environment (land, sea and air) and promotes economic and social well being for its community partners; while respecting the unique cultural and traditional requirements of our Indigenous communities.

The ELC wants to ensure stakeholder and rightsholders concerns are clearly understood and addressed by Northern Pulp. The ELC has been meeting with and reviewing input from public stakeholders since its inception in October 2020.

In April 2021, the Supreme Court of British Columbia (the "Court") overseeing Northern Pulp's Companies' Creditors Arrangement Act ("CCAA") proceedings, formally recognized the volunteer members of the ELC as a standing Ad Hoc committee within the CCAA proceedings. Reporting to the Court-appointed Monitor, the ELC will among other things attempt to identify, review and prioritize potential environmental, forestry, marine, and community engagement issues and solutions related to Northern Pulp's operations and Mill restart plan.

ELC members have diverse backgrounds and views on Northern Pulp's operations throughout Nova Scotia, and the Mill site. Committee members do not represent any specific stakeholder group and are volunteering their time as individuals. The current members of ELC are: Marshall Bateman, Stuart Beaton, John Boyd, Mrs. Nancy Dicks, John Carruthers, Jack Fraser, Sandy MacDonald, Nick MacGregor, Kris Hunter, Mrs. Kim MacLaughlin, David MacMillan, Mrs. Julia MacMillan, Mrs. Kathy McMullen, David Parker, Dr. Michael van den Heuvel, Andy Thompson and Kevin Thompson.

In February 2021, the ELC released a report (the "ELC February Report") identifying what it considered to be key factors contributing to Northern Pulp's prior failure to obtain the necessary approvals to build a new replacement effluent treatment facility (the "R-ETF") which ultimately resulted in the temporary shutdown and the Mill's hibernation.

We attempted to consolidate all available information as presented below:

Who Can Vote in the 41st Provincial General Election?

If you are a Canadian citizen who is 18 years or older on election day (August 17, 2021) and have lived in Nova Scotia for the six months or more before the day the election was called (since January 17, 2021), then you have the right to vote in the 41st provincial general election.

Early Voting Options - Vote Early, Vote Safely!

Before election day voters can vote safely at any returning office or early voting location in the province.

Returning Offices are open: Mondays to Saturdays - Closed Sundays - 9am to 6pm - or until 8pm Thursday, August 12, and Friday, August 13

Community Polls

Saturday, July 31 to Saturday, August 14 - 9am to 6pm, or until 8pm Thursday, August 12 and Friday, August 13. Closed Sundays

Advance Poll

Saturday, August 7 to Saturday, August 14 - 9am to 6pm, or until 8pm Thursday, August 12 and Friday, August 13. Closed Sunday August 8.

You can vote safely at any early voting location in Nova Scotia

Write-In Ballots

Due to the COVID-19 pandemic, Elections Nova Scotia anticipates more voters than ever before may choose to vote by mail using a write-in ballot during the 41st Provincial General Election.

All eligible voters in Nova Scotia can vote by mail using a write-in ballot. Voting by mail using a write-in ballot is safe and easy. Here are the procedures to obtain a "write-in" ballot:

- You must first apply in order to vote by write-in ballot. Please see application information below.

- Once your application has been processed by Elections Nova Scotia, you will receive your write-in ballot kit with instructions on how to fill it out and return it.

You must vote by write-in ballot (instead of at an in-person voting location) once your kit has been issued.

- The deadline to apply on-line or by mail for a write-in ballot is Saturday, August 7 at 6pm.

If you need assistance applying for a write-in ballot, you can contact your local returning office.

All write-in ballots must be returned by 8 pm on election day.
