Age of Sail Museum Expansion Full Steam Ahead

On Nov 20 members of the Greville Bay Shipbuilding Museum Society (Age of Sail) joined representatives of the Municipal, Provincial and Federal Governments, CRDA and local community in a \$264,000+ announcement for funding to the completion of the museums new Wind and Wave Building. ACOA is funding \$130,000 for this phase, the province \$75,000, and the Municipality of Cumberland County \$34,000.

This along with \$25,000 raised by the Greville Bay

Shipbuilding Museum Society will be used for finishing construction of the new building, a wharf and kiosk as well as enhanced signage and land-Cumberland, scaping. Colchester and Musquodobit Valley MP Scott Armstrong congratulated the society and

community on their determination and hard work. Cumberland North MLA Brian Skabar spoke of how the expansion will help build a stronger economy in the area. Gerald Read, District 1 Councillor for Municipality of Cumberland County also congratulated the society and spoke of the strength of tourism in our

The half model shaped building will highlight exhibits relating to the seafarers of the area. The lower level will host a public meeting space as well as research area and an archival storage room. The wharf will run along the river to a kiosk depicting the shipyard once located on the

The project has been in the works for several years and has suffered several setbacks including the loss of key contributors Stan Spicer, Dr. John Wagstaff, Sid Hughes and Ross Colins. "This isn't just about needed space," curator Oralee O"Byrne claims "it's about realizing the dreams of these amazing people who envisioned the building and put so much of themselves into this center."

The building committee, headed by society president Ohra Colins, has worked tire-

"Only a Matter of Time" says Taggart



Another accident has occurred at the Masstown intersection of Highway #2 and #4. Two vehicles collided just before the supper hour on Sunday, Nov. 27th. Two ambulances transferred multiple patients to hospital with undetermined injuries.

District 10 Councillor Tom Taggart voiced his concerns with e Masstown Intersection and the number of accidents that have occurred at this location, at a County Council meeting back on August 25, 2011. He said he would like to see accident reports from the RCMP for the past five years to determine if there is enough evidence to support going to the provincial Department of Transportation and Infrastructure Renewal with a request for flashing lights at this intersection. A motion was passed for the RCMP to be contacted by Council to see how to correct the traffic accident problem at this intersection.

The RCMP conducted a 90 minute radar check at the Masstown intersection in October and reported the average speed of vehicles was between 65 and 70km/hr. The posted

Councillor Taggart was quite upset when he heard about this latest accident. "I hate to say I told you so but it is only a matter of time before there is a fatality at his location," he says. ""I cannot for the life of me understand why there is such a struggle to get a light installed." He says he will be bringing the matter up again at the next Council meeting. "We just received a report back from the RCMP late last week and it says there was only one vehicle accident at this intersection in 2011. I am going to ask them to have another look at their statistics, as I am sure I have seen more than one accident over the last year."

Councillor Taggart feels this issue is of the utmost importance. "I am not going to stop until I get a proper traffic analysis done. Summer traffic is much worse and therefore the potential for accidents much greater," he says.
