The November 1 meeting began with an in camera session. However, with no items covered, it became our shortest in camera session. After a couple of questions we adjourned. I thanked council for their support as deputy warden, for the past year. It was a good thing I did as I was defeated by our new deputy warden, councilor Joe Van Vulpin in public session. Congratulations Joe!


We began public council at 5:30 with a years of service presentation to Kelly Seaman. This was followed by a great presentation from Jonathon McLelland, CEO, Cumberland Business Connector. He covered guiding principles, strengths, and weaknesses and highlights of strategic pri-

orities. He also covered areas the connector will not be the lead. A very positive outlook!

Next, we had an overview of the recent climate change retreat in Pugwash. A working document will soon be produced that individuals as well as all levels of government can follow to make a difference. Four dangerous and unsightly premises were next approved for demolition.

Deputy Warden election followed and as previously written Councilor Van Vulpin was the successful candidate. Motion of approval for 2 stream recycling received approval. Information will follow in the near future.

The Parrsboro interim financial statement as well as a summary of the Municipality's financial state-

ment was discussed and approved. Next a motion to amend our solid waste bylaw to include 2 stream recycling was approved. The RV park development in Springhill will have another meeting to

ensure all are on the same page.

A recommendation to declare a number of properties surplus and be offered for sale was approved. Three grants were approved next as well as support for the United Way. A portion of Main Street in Parrsboro was approved for full paving as a result of recent water and sewer improvements. Information items included council meeting info on in-camera items; tax collection report; Jr C Colts contract, and municipal affairs session on cannabis. Two thank you's were also in our package. Council meeting of November 15th began at at

6pm with public council and no in camera. First up was a presentation from the Pugwash Farmers Market looking for funding for permanent kiosks for vendors. Very informative and we will make a decision in the near future.

Next were four dangerous and unsightly properties and all approved for demolition. A temporary borrowing resolution for Pugwash Water and Parrsboro Waste Water was approved next, followed by a financial update on capital expenditures.

The tender for Springhill downtown infrastructure renewal project was approved pending the end date for completion. Next we approved first reading of the revised local improvement bylaw. Meeting dates were approved for December the 13th and January 17th due to

holidays.

Information items included a labor management report; municipal affairs one year notice letter regarding changes to the workers compensation act; joint letter regarding Chignecto Isthmus infrastructure risk regarding high risk to national infrastructure; dangerous and unsightly update, the two staff are doing exceptional work throughout the municipality; public libraries report and Cape Sharp Tidal update. Councilors were also asked to submit their thoughts on conference attendance going forward.

ize specific facilities but does review projects or activities that have the potential to impact fish or fish habitat.

In cases where projects or activities are likely to result in serious harm to fish, The Department may issue an authorization if the project or activity will not impact the ongoing productivity or sustainability of fish populations.

The Department does not have any official reports of fish mortalities associated with the Annapolis Royal Generating Station. If anyone observes fish mortalities anywhere in Nova Scotia they can report it to the Environmental Emergency phone number at 1-800-565-1633.", was the end of message.

However to prove Dadswell's comment to be totally true, things started to evolve when I received an email from Tiffany Chase, Senior Communications Advisor, Nova Scotia Power at 3:14 pm on November 9th about two hours after Bornais' response. Here is a copy of her message: "Hi Maurice, I'm reaching out as I understand you are working on an article about the Annapolis Tidal plant. We had an inquiry today from the Herald, and I wanted to make sure that you had the same background and context on this facility from Nova Scotia Power for your purposes.

The Annapolis Tidal plant was constructed by the former Crown Corporation and began generating electricity in 1984. It is one of only a few tidal plants in the world, and the only one of its kind operating in North America.

The Annapolis Tidal plant produces clean, renewable energy for Nova Scotians - at peak, it can generate up to 20 megawatts of electricity which is enough to power 4,500 homes. It does so in compliance with the law, and without any significant

impact on fish populations.

The Annapolis Tidal plant does not require provincial operating approval as per S. 5D(c) of the Activities Designation Regulations made under S. 66 of the provincial Environment Act,

as the tidal plant uses "brackish water from an intertidal zone of a river estuary". However, Nova Scotia Power works closely and collaboratively with our federal and provincial regulators to operate all of our facilities within their requirements.

Nova Scotia Power takes environmental stewardship very seriously. We have searched our incident reporting records - which extend back to 2002 - and there is no record of fish mortality at this facility.

We continually seek ways to protect the local fish habitat near our hydro generating stations and make investments to maintain and nurture fish populations. We're committed to continuing that work with our communities, regulators, and doing what we can to protect the local environment, while balancing the need to provide our customers with clean, renewable electricity for years to come.

Please let me know if you have any questions, Tiffany, which was the conclusion of her message.

Immediately, I commenced to believe Dadswell's claim DFO and NS Power in cahoots, as I had not mentioned the original email to anyone.

I stewed about the situation for a couple of days, then late in the afternoon of November 15th, I emailed a letter to Hon Dominic LeBlanc, Minister of Fisheries, with the following message in the body of the email: "Dear Mr. LeBlanc: Please refer to the attached document express-

ing my concerns about leakage within 24 hours, regarding an inquiry requesting information, which was forwarded from one of your staff in Maritimes Region to Nova Scotia Power. I look forward to your personal reply".

I knew a letter to the Minister would get the ball rolling. Within a day or so, I received a call from Mike MacLean, who heads up the Maritimes Communications section for DFO. He informed me he was asked by the Minister's office to call me and part of his message was to admit Bornais had communicated with NS Power. My response was all communications people need to reach out to others to get the complete answer, but they do not need to pass along information on who is inquiring.

MacLean also stated that as a result of media reports concerning fish mortality at the Annapolis Royal site, Fisheries Protection staff are investigating.

I don't mean to editorialize, but the interactions between DFO staff and NS Power seems to prove what people have been saying for years, "whatever Nova Scotia Power wants, DFO will accommodate".

Question: Do these revelations confirm they are in the same bed and using the same pillow?"
