

Looking Ahead to 2020 Municipal Elections

Even though municipal elections across Nova Scotia will not be held until October 17, 2020 some people are advocating the electorate must become more engaged.

In 2016 Colchester's current council was determined by 9 of 11 councillors returning to council via acclamation.

Candidates stepped forward in Districts 2 and 11. Incumbent Bill Masters, District 2, who was first elected in 2000, and served as Deputy Mayor for several years captured 82.77% of the vote to easily beat Shawn Duffy, 567-118.

In district 11, Wade Parker faced competition from Tom Burke, but won 50.59% of the vote in a tally of 416-403. Parker, a red seal auto body technician was first elected in 2012.

Councillor's elected by acclamation included: Geoff Stewart, District 3, first elected in 2012; Mike Cooper, District 4, first elected in 2008 is serving his third term as Councillor. In District 5, first elected in 2008 Lloyd Gibbs is serving his second term as Councillor.

Karen MacKenzie is serving her third term as Councillor in District 6 having been elected in 2008. Mike Gregory was first elected to Council in 2012 and is serving his second term as Councillor for District 7.

Ron Cavanaugh, District 8, was first elected to Council in 1988, serving two terms until 1994. He was re-elected in 1997, and returned by acclamation in 2000, 2004, 2008, 2012, and 2016. Bob Pash served his first term on Council from 1985-1988. He is now serving his second term as Councillor representing District 9.

The 9th councillor to be elected by acclamation includes Tom Taggart, first elected in 2008, is serving his third term as Councillor in District 10.



There was a contest for the Mayor's position with veteran Bible Hill councillor, Christine Blair defeating incumbent Mayor Bob Taylor for the top position. Blair captured 53.02% to Taylor's 46.98% to win 3051-2703. Mayor Blair is serving her first term as Mayor for Colchester County. She also served three terms as Councillor for District 1, representing Bible Hill and Valley from 1997-2000; Bible Hill and Brookside from 2008-2016.

Taylor was first elected mayor in 2008 winning the top post in 2008 and 2012. He had previously served as councillor for 11 years. The electorate was disengaged with 20.28% turnout for the mayoralty position, while the two council districts elicited a turnout of 26% and 31%. A total of 1,604 cast votes in the two council districts. Colchester County is a jurisdiction of 38,000. Average age of council is 64. Around the council table, except for Councillor Karen MacKenzie and Mayor Christine Blair, 83% are male.

During late summer, a recent failed attempt to introduce a temporary Kennel By-law ignited some discussion for more people to seek public office. The proposed temporary by-law resulted in several public protests and some kennel operators were vowing to find candidates to run in each electoral district.

OpenHydro Seeks \$17-Million Tax Credits

Even though the tidal turbine is not functioning; the company is bankrupt and over \$6-Million is owed to several of Atlantic Canada's most prominent marine companies, the corporate entities involved in the defunct tidal turbine on the FORCE site near Parrsboro are seeking over \$17-Million in tax credits.

An affidavit filed with the Supreme Court of Nova Scotia on behalf of Open Hydro Technologies Canada Ltd indicates the company has filed for credits in three categories: \$7,360,751 in provincial tax credits under the scientific research and experimental development program for the fiscal years 2015 and 2016;

\$6,318,954 worth of the same credits at the federal level and a \$4,127,686 Capital Investment Tax Credit with the provincial government.

In early November, Laurent Schneider-Maunoury, who is listed as president of French defense contractor Naval Energies, parent of OpenHydro was also listed as a director of Open Hydro Technologies Canada Ltd.. In a filing with Nova Scotia Registry of Joint Stock in early November, Scheider-Maunoury and that of Alisdair MacLean were removed as directors.

Apparently, the application

is presently under review and is the subject of a number of questions and request for documentation and clarification from the Government of Nova Scotia. Scheider-Maunoury has suggested the company wishes to undertake an orderly wind-down and liquidation of its affairs under the supervision and approval of the Court. That wind-down would include maintaining and preparing to sell the purpose-built barge Scotia Tide; planning for the removal of the experimental turbine placed in the Minas Passage.

Sources suggest removal of the turbine might not be possible until mid-May. Other early November documents show the company has been approved for a one time loan of \$500,000 from its bankrupt Irish parent company to fund its operations and legal expenses for another month.
