## **Brothers Perish** in Freak Accident

Lobster fishing brothers Croyden and Michael Wood, Parrsboro perished in a freak accident near Parrsboro on Friday, January 20th.

The two using ATV's and a trailer left on late Friday afternoon to check their lobster traps, but succumb to the turbulent Bay of Fundy tides.

They failed to return home later than evening. Their bodies were recovered on Saturday after frantic efforts by RCMP, friends, relatives, Search and Rescue

Croyden, Jr, "Boo", 48, is survived by his companion, Brenda Dawn (Downey) Perry, and her children, Clinton, Justin, Ajay and Angel, all at home. Michael, 41, a younger brother is survived by his wife, Tanya (MacFarlane) Wood, Parrsboro; sons, Grant and Keith both at home

They were the sons of Croyden and Frances (Gilroy) Wood, Parrsboro. Other family members include a sister, Patty Wood, Moncton; brothers, Arnold

(Janet), Parrsboro; Bentley (Paula), Porter's Lake; numerous aunts, uncles, nieces, nephews and cousins.

Funeral for Croyden and his brother, Michael was held in Trinity United Church, Parrsboro on Thursday January 26, 2012. Rev. Tory Byrne, Rev. Greg Doyle and Rev. Keith Smith officiated.

A trust fund has been established for each brother for the benefit of Croyden's step-children and for for the benefit of Michael's children.

## Life in Prison for 2000 Murder

It took nearly 12 years from September 2000 to January 10, 2012 for the Maddison family Portapique to learn the fate of the person, who murdered Charles Maddision, 55 after picking up a hitchhiker while enroute to a medical appointment in Halifax. Michael John Lawrence, 37, Windsor pleaded guilty to three first degree murder charges in a Kentville court room.

Justice Gerald Moir imme-

diately sentenced Lawrence to life in prison without parole for 25 years.

Lawrence also pleaded guilty to the following day committing the first degree murder of husband and wife Kirk Mersereau and Nancy Christensen of Centre Burlington, Hants County.

Lawrence admitted to being picked up by Maddison then forcing him to drive to a secluded area in Hants County, where he shot him,
