then took is truck, which he wanted to commit other crimes. Maddison's body has not been found. Several members of the Maddison family attended court for the guilty plea and sentencing. Maddison's mother, 89 year old Etta Maddison, Springhill said, she has "been crying inside all those years". Maddison family members including a daughter, sister

and nephew declined comment when leaving the courtroom.

In jail and awaiting court appearances are Leslie Douglas Greenwood, 41 and Curtis Blair Lynds, 34 who are each charged with first degree murder in the Mersereau and Christensen murders. Both Greenwood and Lynds are charged with being accessories after the fact in Maddison's murder.
