## RCMP and DNR Enforcement a Successful Partnership

Colchester District RCMP and Department of Natural Resources Enforcement officers continue to be successful in joint investigations. Since early October they have laid charges against eight males in several incidents.

On October 10, 2014, DNR Enforcement officers conducted a checkpoint on Upper Belmont Road in Upper Belmont, to target hunters violating the Wildlife Act. During this checkpoint DNR officers stopped two men for the suspicion of impaired operation of off-road motor vehicles. Colchester District RCMP subsequently arrested a 56 year old man from Debert and a 38 year old man from Saint John, New Brunswick, both for operating an ATV while under the influence of alcohol.

On November 02, 2014, Colchester RCMP responded to a report of shot's heard and flashlights seen after dusk in Old Barns. Police and DNR officers attended and arrested four males who have been charged with numerous offences under the Criminal Code and the Wildlife Act. Facing charges are a 43 year old man from Sydney Mines, a 53 year old man from Gillis Lake, a 49 year old man from Millvale and a 56 year old man from Topsail, Newfoundland.

On December 11, 2014, Colchester and Millbrook RCMP responded to a complaint of deer jacking in the Brookfield area. A 19 year old male from Salmon River and a 19 year old male from Truro were arrested and charged under the Wildlife Act.

These investigations also resulted in the seizure of several vehicles and firearms. All accused have been released and have pending court dates at Truro Provincial Court. Colchester District RCMP and the Department of Natural Resources Enforcement

continue to work in collaboration to enforce the Criminal Code and the Wildlife Act. Both agencies wish to thank concerned residents and ask that if anyone have any information regarding Wildlife Act offences to notify their local police or DNR office.
