The proposed class action seeks to represent all persons or entities who purchased or leased a diesel-powered Dodge RAM 2500 (2WD, 4WD), model years 2007-2010; Dodge RAM 2500 (non-SCR systems, 2WD, 4WD), model years 2011-2012; Dodge RAM 3500 (2WD, 4WD), model years 2007-2010; or Dodge RAM 3500 (non-SCR systems, 2WD, 4WD), model years 2011-2012.

**The province will spend** \$9.1 million to build a 12-station dialysis unit at the Valley Regional Hospital in Kentville. Construction will begin this fall. When completed the new Kentville unit will replace a six station in Berwick which currently serves 24 patients. The new facility will be capable of handling 48 patients which it is completed in mid 2019.

**The Government of** Canada launched a public consultation on new rules to strengthen food safety. The proposed *Safe Food for Canadians Regulations* would better protect Canadian families by putting a greater emphasis on preventing food safety risks for all foods imported into Canada or sold across provinces. The regulations would also apply to foods prepared for export. The proposed regulations would require food businesses to have preventive controls in place to identify and manage food safety risks before products are sold to consumers. This would also reduce the time it takes to remove unsafe foods from the marketplace. This public comment period is an opportunity for all Canadians to comment on the proposed regulations. These proposed regulations represent a major milestone in bringing the *Safe Food for Canadians Act* into force, which was passed in Parliament in 2012 with support from all political parties.

**Nova Scotians are** encouraged to present their views about the province's first accessibility legislation, Bill 59, to the Law Amendments Committee. The Law Amendments Committee sessions will be at Province House, 1726 Hollis St., in Halifax on Monday, Feb. 13, from 1-5 p.m. and 7-9 p.m., and on Tuesday, Feb. 14, from 9-11 a.m. Those interested in presenting on Bill 59 should contact the Legislative Counsel Office at 902-424-8941 or [Legc.office@novascotia.ca](mailto:Legc.office@novascotia.ca). **Two new judges**, including the first Mi'kmaw woman to join the judiciary, have been appointed to the provincial and family court. Catherine Benton, a lawyer with Nova Scotia Legal Aid from Lunenburg County, has become the second Mi'kmaw to serve as a judge in Nova Scotia. Ronda van der Hoek, a prosecutor and team leader with the Public Prosecution Service of Canada, was also appointed to the bench today (January 23rd) by Governor in Council on the recommendation of acting Attorney General and Minister of Justice Michel Samson. The provincial court presides over most indictable offence charges under the Criminal Code and has exclusive jurisdiction over all summary offence charges under provincial and federal statutes and regulations except a charge of murder by an adult. The family court provides a forum to hear family issues, including maintenance, custody and access and child protection matters.
