

Extending Christmas in Wentworth

Christmas Day, December 25, on the Gregorian calendar, and its decorations is extended in some Wentworth homes and events to January 7 which is Christmas Day of the Eastern Orthodox Church and the Ukrainian Greek Catholic on the Julian Calendar.

Church members in Wentworth, who have celebrated Christmas Day on January 7 with Ukrainian friends, mentioned this in conversation and I asked them to send me an email in order to liven up the reality of Christmas Day on January 7.

I received three notes which follow:

Note #1: The Wentworth Learning Centre earlier had a Tree Lighting Ceremony on December 2, 2018, in memory of Josie Lynn Crawford, six years of age who died in a tragic house fire in 2007. The Tree, still lit, is adjacent to the Gazebo which is dedicated to the memory of both Josie and her father, Justin Crawford, who died in the same house fire. A staff member on behalf of the Learning Centre said:

"The Tree is left lit until January 7, 2019, to honour Justin and Josie's memory for a full month." Two photos are attached: Photo #1. The Christmas Tree and Photo #2. Children gather around the Josie-Lynn Memorial Christmas Tree.

Note #2: A Wentworth resi-

dent commented: "In the early 1960's, I was teaching in Calgary, Alberta, and spent my first and last Christmas away from home. At that time I was sharing an apartment with an Ukrainian girl and we had two Christmases: one in December 25 and one in January 7. It was interesting to learn how the Greek Orthodox Church celebrated Christmas."

Note #3: Another Wentworth resident commented: "I boarded with a Ukrainian family while attending university in Toronto and celebrated with them when invited to a special Christmas supper and event on January 7. I had not been aware of this second Christmas Day on January 7. I usually remember this second Christmas every year by keeping my Christmas lights lit until January 7."

I do not know how many people in Nova Scotia are aware of this second Christmas Day of January 7 when Christ's birth is celebrated or that the celebration continues for 12 days in the Julian calendar as it does in the Gregorian calendar. In the Gregorian calendar, December 25 extends from Christmas Day to the Epiphany (January 6) when the wise men arrive with their gifts and initiating the idea of giving gifts at Christmas. In the Julian calendar, Christmas Day, January 7, extends celebration to January 19.

I mention this extension of

Christmas in Wentworth to spread the news, and also to give a greeting in Nova Scotia to those people who do celebrate January 7 until January 19 as part of their ancestry and religious heritage.

The Cumberland Singers, directed and coordinated by Jocelyn Morris, invited the public to the Wentworth Recreation Centre by saying in a publicity statement, "The amount of \$3,004 raised at this concert was from admissions, raffle, bake tables and three private donations and was given in shared amounts to Victorian Order of Nurses and Wentworth Youth Hostel".

The majority of the Cumberland Singers are descendants of Ellsworth and Edith Patriquin who were parents of 12 children. Two of their daughters, Pearl (Patriquin) Crowley and the late Jean (Patriquin) Mooring-Baker, in 1982 began raising funds for good causes until 1991 and eight years later in 1999, Jocelyn Morris, daughter of Pearl Crowley, named and organized the Cumberland Singers with family members to raise funds for charity and non-profit organizations. In 2018, the 22 performers included 19 who were descendants by blood or marriage of the Patriquin family and three who were friends.

Three friends were Shane Lyons, Angela Trenholm, and Wayne Reid. Concerning the above names, 13 were individual singers, 6 performed in the choir only, and the last 3 were child performers. Some of the individual singers were also members of the band &/or sound team.

The concert had two sets of 27 songs or hymns sung by individuals as solos, trios, and quartets backed by the band, and a complete choir of singers performing three selections at the beginning and three selections at the ending. Jocelyn Morris and Sharon Miller each changed into picturesque costumes several times, catching the interest of the crowd. Behind the performers on stage was a white sign with decorations and musical notes stating emphatically The Cumberland Singers. Volunteer workers were an important part of the successful concert being at an entrance table, raffle table, a SPCA table, bake table, bar, canteen and kitchen.

Will "Assessment Cap" be Removed?

(Editor's Note: With the possibility the "CAP" might be removed from residential property assessments, the Shoreline Journal has consulted with Municipality of Colchester and Property Valuation Services to obtain background data. As a result we have generated potential "What If" scenarios, as outlined below).

A preliminary analysis indicated if the Residential Cap is removed Colchester base tax rate might be reduced by \$0.13/100 - going from \$0.88/100 (2018 base rate) to \$0.75/100. Taxpayers are warned not to jump to conclusions. If the CAP were removed, their property taxes would be based on assessment value noted on the annual assessment information received, just about this time, each winter from Property Valuation Services.

The revised tax rate would be calculated with the Assessment Value to calculate

payable tax. None of our analysis or projections included any of the multitude of area or service rates. We randomly chose four properties without the cap, and calculated the tax payable, on base rate, not including any area or service rates.

Although it's not scientific analysis, and some assumptions are required, the following could apply to Colchester residents:

- Based on 2017 assessment data, the total assessed value of Residential Properties in Colchester is \$2.306 Billion, (\$2,306,002,000).
- Based on 2017 assessment data, the "cap" value for Colchester residential properties is approximately \$ 2 9 8 . 8 - M i l l i o n , (\$298,882,200).
- Value of Colchester residential properties "included in the cap category" is 12.95% of total Residential Property Assessment. (See portion of resolution later in this story)

Consultation with Property Valuation Services, the crown corporation which provides property assessment services to the Province revealed:

The value of a CAP on any residential property depends upon the length of time that property has been "capped".

The value of the cap is determined by a variety of factors including: length of time, value at time of CAP, location; potential resale value and other assessment tools.

Once a property is sold, the "cap" is removed, unless the property is sold to a family member.

Once a property is sold, it will be re-assessed, and a new CAP value will come into effect in the next fiscal year.
