tion to purchase adjacent land; \$150,000 from the Province; \$20,000 committed by the Community Foundation of NS; \$5,000 donation from Big Brothers Big Sisters and \$25,600 in donations from other sources.

Streetlights for Gorman Road?

During committee meeting on January 15th, Director of Public Works director Newell reported on her finding regarding street lights on Gorman Road. The matter originated with a letter from Ms. Elizabeth

Thompson at the November 20, 2020 meeting whereby she was requesting streetlights on Gorman Road in North River. In her letter, Ms. Thompson referred to streetlights on Ella Jane, which Director Newell clarified stating the residents on the Ella Jane subdivision pay an area rate, however Gorman Road is outside of the Urban Service boundary, and therefore residents are not paying for streetlights.

Newell outlined Under the County's Local Improvement By-law, streetlights could be installed on Gorman Road provided a formal petition shows more than 50% of owners and 50% of assessed value were in favour in favour of the improvement.

The annual cost of a streetlight is \$240, bringing the total estimated annual cost for 13 lights on Gorman Road to \$3,120. If the number of streetlights was reduced, the annual cost would also be reduced. This amount would be

shared among the 41 property owners based on assessment, meaning the majority of costs would be borne by the 23 homeowners.

The current by-law requires a public meeting to be held as part of the process, once it is determined a formal petition confirms at least 50% approval rating.

However, with CoVid prohibiting such public meetings, Newell asked to deviate from the by-law with a mail-out whereby each resident would receive an individualized petition with their estimated annual cost for the streetlights and would be required to mail back their decision.

Staff were given approval to commence a petition to the 41 property owners.

388 kg's of Needles Received

During Covid many pharmacies stopped accepting sharps for proper disposal. There was great concern that the public may put them in their recycling or garbage. This is very hazardous for the collections and solid waste operations staff.

The Waste Reduction Department organized three free drop off events for the public to bring their back log of needles for proper disposal. All collected sharps were dis-

posed through Stericycle. Over 388 kg's of needles were received.

Staff have moved to developing educational presentations and messaging on social media, because we have less in-person presentations. Approximately 22 videos were created from April 1st to December 31st, 2020, covering such topics as 'What Goes Where' for each stream, illegal dump clean ups, reducing food waste, profiling Colchester solid waste operations

541 Education Hours Completed

We are receiving reports on green cart request, illegal dumping reports and downloading of the residential collection calendars. Recollect is the electronic collection calendar software. Between April 1sts to December 31st, 2020, we had 618 new addresses, 78,874 calendars viewed, 2,069 calendars printed and 26,525 first time visitors.
