Bible Hill to Host Highland Games?

Colchester council committee agreed to provide a letter of support to the Colchester Highland Games and Gathering Society for an event planned for Bible Hill as part of the Canada 150 celebrations. Council also approved recommendations from the nominating committee to add individuals to several committees. Details of the committee additions can be located elsewhere in this issue.

As a result of considerable discussion in previous meetings, council repealed and approved a new policy on Crosswalk Installation Policy and Crosswalk Supervision Policy, which have been brought forward and recommended by staff.

It was announced a new Regional Economic Network (REN) has been approved involving Colchester, Truro, Millbrook and Stewiacke, which will fill the void from CoRDA being disbanded a few years ago. Details were not revealed, but a press release will be released soon. It's understood the REN board

will be heavy on business owner involvement and supervision for the municipalities will be handled by a liaison committee comprised of council representatives.

An information item was presented to council outlining staff's study of Sewer Extensions in Great Village.

Council's approved 5-year capital budget contains only \$25,000 for design costs for a sewer extension along Highway #2 in Great Village in fiscal 2017/18. There are no monies budgeted for the construction of any sewer system extensions in Great Village. The current sewer area rate in Great Village is 12 cents per \$100 of assessment. Of the 12 cents, 4 cents are directed to capital and 8 cents are directed to operating.

Three options had been considered and are presented below:

Option 1 would service an additional 36 homes and 7 vacant parcels with a total taxable assessment of \$3,866,000. This would yield an annual revenue of \$4,639 from the sewer rate of which \$1546 would be directed

towards capital. Based on the capital construction cost of \$1.3M, the return on investment on the project would be 840 years unless another source of funding was identified. Where a typical funding program covers 2/3 of capital costs, the County portion could be reduced to \$433,000, reducing the return on investment period to 280 years.

Option 2 is being considered as the extension along Highway 2 up to civic #63 on Station Road. This extension would service an additional 10 homes and 7 vacant lots with a total taxable assessment \$585,000. This would yield an annual revenue of \$702 from the sewer rate of which \$234 would be directed towards capital. The capital construction cost for this section is estimated at \$450,000.

Option 2A is being considered as the extension along

Station Road from Civic #63 to Civic #137. This extension would service an additional 4 homes and 1 vacant lot with a total taxable assessment of \$636,000. This would yield an annual revenue of \$763 from the sewer rate of which \$254 would be directed towards capital. The capital construction cost of Option 2A is estimated at \$665,000

Realizing the project was too costly, Public Works Director, Michelle Newell said she was going to check into a program she understood has evolved in Richmond County, which involved the municipality making improvements to or building new sewer fields in areas, where beds not working properly were fixed, plus ongoing maintenance and pumping sewage tanks managed by the municipality with the costs being paid by the taxpayer over a period of years. She will report back to council at a future meeting.
