Wentworth Schools 1914- 1917

Checking back on one-room school history in Nova Scotia, grades one to eleven with one teacher in the one room, I found a research article which I did for the North Cumberland Historical Society and printed in their Newsletter on July 2002. During my research, I came across the names of past members of my family who helped maintain the Wentworth Center School (spelled Center in those days): two of my grandfathers (Rev. W.R. Tratt and Stephen Tuttle), a great uncle (Alan Tuttle), my mother (Lillian Tuttle), and my father (Heber Tratt). It is inspiring to note their contributions to the school section of that time as they worked together with other Wentworth residents for the sake of educating community youth.

Following is a Form of agreement which my mother, Lillian Tuttle, signed when being hired as a teacher in 1914 by the trustees of the Appleton School Section No.13: "Membership of Agreement made and entered into the 2 day of February A.D., 1914, a duly licensed teacher of the third class, of the one part, and Isaac Patriquin, Wilbert Lynds, and Leonard McGill, trustees of School Section No. 13, in the district of Cumberland of the second part. The said Lillian Gladys Tuttle on her part, in consideration of the below mentioned agreement by the parties of the second part, hereby covenants and agrees with the said Isaac Patriquin, Wilbert Lynds, and Leonard McGill, trustees as aforesaid, and their successors in office, diligently and faithfully to teach a public school in the said section under the authority of the said trustees and successors in office, during the school year ending in June next.

And the said trustees and their successors in office on their part covenant and agree with the said Lillian Gladys Tuttle, teacher as aforesaid, to pay the said Lillian Gladys Tuttle out of the school funds under their control, at the rate of one hundred dollars for the school year in equal installments semi-annually. And it is further mutually agreed both parties of this agreement shall be in all respects subject to the provisions of the school law and the regulations made under its authority by the Council of Public Instruction: "In witness whereof, the parties to these present have hereto subscribed their names on the day and year first above written. Teacher: Lillian Gladys Tuttle, Trustees: Leonard McGill, Isaac Patriquin, Wilbert Lynds."

In addition, according to the Education Act in 1914 the teacher had "to inculcate by precept and example, a respect for religion and the principles of Christian morality, and for truth, justice, love of

country, loyalty, humanity, benevolence, sobriety, industry, frugality, chastity, temperance and all other virtues...appropriate instruction shall be given in all the public schools as to the nature of alcoholic drinks and narcotics, including tobacco, and special instruction as to their effect on the human system, shall be given with the subjects of physiology and hygiene. Such instruction shall be given orally to pupils unable to read and from a suitable textbook in the hands of the teacher, and to all other pupils from such textbooks, in the hands of the pupils as is time to time prescribed by the Council." The Education Act in 1914 in no uncertain terms stated the importance of teaching ethical values to students.

Wentworth Center School Section No.12, District No.9, operated under the jurisdiction of provincial and municipal authorities (Council of Public Instruction-Members of the Provincial Executive Council, Advisory Board of Education, Commissioners of Education), but the power invested in the trustees, secretaries, and ratepayers within each one-room school meant that most decisions were made locally although within the dictates of the Education Act. At an annual ratepayers (men owning property) meeting the last Monday in June, a secretary to the trustees would be elected, and the secretary was entrusted with many duties, including being a treasurer and collecting school taxes from the ratepayers. The school tax was based on the municipal assessments which came from the Municipal Council in Amherst and a poll taxes paid by unmarried men (\$1 each). The local school taxes were supplemented by a provincial grant (to be used towards a teacher's salary) and a municipal grant (to be used towards

general school purposes).

At an annual ratepayers meeting, certain items had to be done according to school law: #1. To elect a trustee or trustees; #2. To bring in a budget for the coming year; #3. To discuss items essential to the proper management of the school section.

Following is an example of annual minutes from Wentworth Center School Section No.12, district No. 9 on June 25, 1917: Wentworth Center, June 25, 1917. Minutes: Annual school meeting of Section No. 12 were opened by a call to order from the chairman, Allan Tuttle. Moved by B.H. Swallow, seconded by G.H. Swallow that Heber Tratt be secretary for the meeting. Carried. Minutes from previous meeting were called for and read. Moved and seconded that they be accepted. Carried. Auditor's report was then read. Moved and seconded that report be accepted as read. Carried. Moved by G.H. Swallow, seconded by Charles Nelson that Neil Feeley be elected to fill vacancy in Trustee Board. Carried. Moved by B.H. Swallow, seconded by Stephen Tuttle that three hundred and eighty dollars be voted for school purposes. Motion carried. Moved and seconded that wood be supplied free by ratepayers for the year. Motion carried. Heber Tratt, Secretary; Allan Tuttle, Chairman."

This column gives a brief picture of how the education system worked a hundred years ago. It was very different from the digital age of technology and the social values of 2017. I do have photos of past family members which I show as representatives working for community education and one photo of a Tuttle grandson who is standing in front of the Wentworth Center one-room school and who benefited from their work.
