Sales of Flavoured Cannabis Vaping Products Banned

Nova Scotia is taking further steps to protect youth by banning the sale of flavoured cannabis vaping products when they become available in the new year. Regulations are being prepared to prohibit the sale of cannabis vaping products that have a scent or flavour other than cannabis noticeable before or during use. No synthetic flavouring will be allowed. Packaging and labelling will also be prohibited from mentioning a flavour other than cannabis.

More than 2,200 cases of severe lung disease have been reported in the United States among people who vape e-cigarettes or cannabis products, with 48 deaths. There have been thirteen such cases of severe lung disease reported to the Public Health Agency of Canada. The causes of death have not yet been determined

Expanded Pharmacy Services

Two agreements between the government and the Pharmacy Association of Nova Scotia means more provincial funding for pharmacists' services. Starting Jan. 1 pharmacists will be funded by the province to assess and prescribe birth control, medication for urinary tract infections and shingles. Starting April 1 pharmacists will also be funded to renew prescriptions for 180 days for many items, including asthma inhalers and blood pressure medications. Government is investing \$9.14 million over the five-year agreement. There are 1,300 pharmacists and more than 300 pharmacies in Nova Scotia

10 stolen recreational vehicles recovered

On December 5th, police have charged four people after recovering 10 stolen recreational vehicles valued at \$40,000. Four people all in their early 30's have been charged. Two of the people are from Amherst; one from Aulac, NB and the other from Moncton. The investigations are ongoing and led by Cumberland County SCEU and Amherst Police Major Crime Unit.

Post Election Report

Several recommendations were included in the post 2016 municipal election report prepared by returning officer, Lorraine Dawson. Some of the recommendations included:

Evaluate the electronic voting process to employ e-voting in the Municipality with one polling station in each district using the traditional paper ballot on election day.

Review the requirement for signage at polling locations with the intention of providing at least two signs each location and obtain a plastic banner to be placed on or adjacent to the entrance of each polling location.

Request a version of Elections Nova Scotia data base system be provided with the List of Electors. This would facilitate changes input by office staff and ensure the updates are captured for future elections when the list is returned to ENS.

This election was conducted in 51 polling stations in 24 locations. Advance polling stations were conducted for two days in each of the 11 districts and 4 mobile polls serviced the homes for long term care.

Many complaints were received concerning signage. The report stated, "Signage is important. In many areas the provided plastic sign on the post, located at the entrance to the polling location was not adequate.

nications Officer/Executive Assistant to the CAO Municipality of the County of Cumberland sent out an email stating, "Due to road conditions and uncertainty regarding pending weather, please be advised that the Council session scheduled to be held this evening (December 11) is being cancelled.

Her email continued, "Our next Council session will be held January 15th, 2020 and an agenda will be forwarded during the week prior to the meeting".
