ing sexual services in public places where a child could reasonably be present; and, Increase existing penalties relating to child prostitution.

These measures will be supported by \$20 million in new funding, including to support grassroots organizations dealing with the most vulnerable prostitutes. Recognizing that the overwhelming majority of prostitutes are looking to leave this dangerous and harmful line of work, there will be an emphasis on funding programs with a proven record of helping prostitutes exit the sex trade.

We have introduced this legislation now, well ahead of December 19, 2014, in an effort to ensure that it is adopted and starts protecting those

who are most vulnerable and at risk of the exploitation inherent in prostitution as soon as possible, while ensuring Canadian streets and communities remain safe.

Direct Sellers Act Being Amended

The Direct Sellers' Regulation Act was introduced in 1975 and has not been amended since 1999. Legislative changes introduced on April 8, provide

more protection for seniors and other consumers from misleading or aggressive door-to-door sales.

The amendments will increase penalties to a minimum of \$500 and a maximum of \$25,000 for individuals, and \$300,000 for corporations; limit continuous service contracts to two years; allow government to disclose those breaking the rules to quickly address emerging and unforeseen issues; allow

consumers to cancel continuing-service contracts at any time and modernize and align the act with legislation in other provinces.

The amended legislation provides rights to consumers who make direct-sale purchases and

provides consumers with a 10-day "cooling off" period which allows them to cancel a contract for a refund. People should always ask for proof that salespeople have a permit, or contact the Better Business Bureau.


