## Barnhill's Superette Celebrates 95<sup>th</sup> Anniversary

What was happening in Canada back in the year 1921...well, the Bluenose was launched, Canada was granted a coat of arms by Royal Proclamation and Canada's official colours were declared to be red and white. Much closer to home, C.Homer Barnhill had purchased Barnhill's Superette from the Belmont Trading Company on June 8th, 1921. The Barnhill family has been running the store ever since and this year they are celebrating the 95th Anniversary.

In 1921, the general store sold everything from groceries, lumber, paint, feed and yard goods to gasoline and kerosene.

The store thrived during the war years, especially during the construction at Camp Debert and afterwards, when troops were staged here before going overseas.

The community looked at Barnhill's store as somewhat of a village meeting spot, with customers gathering around the central wood stove to share conversations.

From behind two long wooden counters, Barnhill's was clerk-served until 1971, when Wendell Barnhill (who purchased the store in 1961), did extensive renovations. Several partitions were removed and the store space expanded to include a fresh meat counter. It was now a self-serve operation. Later on lottery sales were added.

Several more changes were made over the years, but commitment to customer service was always kept in mind.

Randy Barnhill purchased the store from his father Wendell on June 2nd, 1983. Working at the store was not exactly a new experience for Randy. "One of my first so-called paying jobs was pumping gas for a penny a gallon. Some days I could make 25 cents, and that was a pretty big deal back then," said Randy during an interview back in 2011, for the 80th Anniversary.

When Randy first took over the store, there were renovations inside and out, changes to store hours, the addition of computerized

cash registers and expanded video rentals. In 2006, at the time of the 85th Anniversary Barnhill's Superette, Pizza Partito was added to the business making 2016 the 95th Anniversary of Barnhill's Superette and the 10th Anniversary of Pizza Partito. In 2015, Pizza Partito surpassed the \$1 million in pizza sales, with more than 70 thousand pizza slices sold.

A 95th Anniversary Celebration was held on Saturday, June 18th with musical entertainment, a BBQ and anniversary cake cutting by the three Barnhill generations.

Presentations were made by MLA Karen Casey and also Colchester Mayor Bob Taylor and Councillor Doug MacInnes. Randy Barnhill thanked everyone for attending the celebration adding, "95 years is a long time for any business, sometimes you hear of multi-national companies getting to be 100 years old but very rarely do you get one small business continuously run by one family for 95 years.

Back in 1921 when Homer bought the business he would never have dreamt we would be selling bottled water, or that people would come in and pick up their own things rather than having him running around with the list picking up things from here there and everywhere, or even that the computer would record all the prices...it would blow his mind."

Those things have made differences throughout the years but Randy credits two things to the longevity of the family business. "What hasn't changed at all is having great staff over the years, which makes things it a whole lot easier, and very loyal customers. It is great that we had those things because we would never have reached 95 years without the great staff and loyal customers."

Barnhill's currently employs a total of 9 people and it is still a family run operation with Randy, his wife Sonya and their daughter Carly working various shifts.
