Parrsboro & Springhill Have Area Rates

Cumberland Council meet on May 25th, after the June issue of South Cumberland News was printed, to approve the 2017/18 budget and set taxation rates. As of June 4th, the general tax levy is \$19,722,723. The basic general or residential rate throughout the municipality is \$1.04/\$100 assessment, while the commercial rate was set at \$2.63/\$100 assessment.

Within our coverage area, Springhill and Parrsboro, the two former towns merged into the municipality last year, each have special area rates. Springhill is \$.86 for residential and \$2.18 for commercial. Parrsboro taxpayers face additional rates of \$.46 and \$1.17 for residential and commercial. Both area rates are based on \$100 per assessment.

Additional sewer rates apply for Springhill and Parrsboro apply for each property. Springhill is \$265

and Parrsboro is \$300. Flat rates also apply for Street Lighting on the County System for Advocate, \$42.54; Port Greville, \$68.00 and Spencers Island, \$81.00

Public hearings for three dangerous and unsightly premises were held at council's meeting on June 14th.

With regard to water utilities, a budget of \$1,338,526 was set for Springhill and \$365,063 for Parrsboro. Construction is underway in Parrsboro to lay new sewer lines to be connected to the new \$Multi-Million new sewage treatment system.

A report from staff indicated that as of May 31, there was \$23,388,505 outstanding in taxes, which is up from \$21,968,045 for the preceding year. Part of the increase is attributed to the merger of Springhill and Parrsboro into the municipality within the last year. Tax collections in May 2017 totaled

\$107,606.

A May 31, 2017 Tax revenue analysis shows 4065 properties owing \$20,414,237. A total of 222 properties are in the preliminary tax sale process with \$1,318,267 in outstanding taxes. A further

\$914,095.16 is committed with arrangements on 411 properties.

Deed Transfer Tax by-laws for Springhill and Parrsboro were repealed to permit the county to have one set of rates. A property at 25 Eddy Street, Parrsboro was the only one from our coverage area.


At 7:00 p.m. local historian Dara Legere will present an illustrated lecture on the August Gale

Refreshments will be served during both presentations which are free and open to the public.




The annual ceremonial review of Parrsboro # 689 Air Cadets was held recently. (Zena Grindlay Photo)
