**On June 18th** more than 5,000 people from across Canada and around the world participated in the IWK Run for Families on the Confederation Bridge as part of BridgeFest 150. They raised more than \$195,000 for the IWK Foundation and donations continue to pour in.

**Jim Eisenhauer**, Michael Donovan and Chris Huskilson were inducted into the Nova Scotia Business Hall of Fame during a celebration of the event's 25th anniversary on May 31, 2017. The event was attended by over 1,000 c-suite executives and business leaders from all corners of industry. Through sponsorship, table sales, a raffle and personal pledges, the event raised \$544,896 in support of JA Nova Scotia programs, which was a record for the event. The event was chaired by Colin MacDonald; 2015 Laureate, corporate sponsor and personal donor.

**On May 20 during** National Impaired Driving Enforcement Day, Nova Scotia RCMP charged 17 motorists for impaired driving and issued nine roadside suspensions. Of those charged with impaired driving, 14 were impaired by alcohol and three were impaired by drug. Additionally this year, Nova Scotia RCMP issued nine roadside suspensions due to driving with a Blood Alcohol Content between 50-80 milligrams of alcohol in one hundred milliliters of blood (50mg% to 80mg%).

**The Department of Natural Resources** is giving every Grade 4 student in the province two free nights in one of Nova Scotia's 20 provincial camping parks. The Grade 4s Outdoors program also gives the students a nature passport to encourage exploration of parks or other natural space. The program exposes young people to the benefits of camping in provincial parks. There will also be a Learn2Camp weekend in July to teach the essentials of camping. ### Reverse Redundancy

Currently, 93% of police, fire, paramedic and ambulance calls in Nova Scotia are handled through two 911 communications centers. The RCMP operates one in Truro and the HRM Police have one in Dartmouth. Having the two equal centers located over 90 kilometers apart means that one center would likely be unaffected if the other area was disabled by a man-made or natural disaster. This is called redundancy. The RCMP is proposing to move its communication center to Dartmouth, eliminating that redundancy,

which provides a safety factor for all Nova Scotians.

This proposal is still being considered despite the fact that a 2004 RCMP comprehensive report on Emergency Communications facilities in Nova Scotia says "It is not recommended that the two largest police communications operations in Nova Scotia be placed within the same metropolitan area". The same report goes on to say, "Primary service delivery site should be outside of HRM due to risks of placing 2 largest police communications centers in close proximity to each other".

Two other frequently used manuals on emergency communications which guide Canadian police forces are the U.S Homeland Security Continuity Guidance manual and the National Emergency Number Association manual. Both emphasize the need for redundancy through separated locations. These reports state that "Organizations should have adequate, separate locations to ensure execution of their functions", and that there should be "sufficient distance between the facility location and other facilities". Also "It is desirable to have at least two layers of redundancy".

The common denominator in these three reports is the need for "redundancy". At the moment, Nova Scotia

has redundancy in the emergency communications system. Locating the two main police communications systems in Dartmouth eliminates that redundancy and puts all Nova Scotians at risk of diminished emergency communications in the middle of a disaster when they need it the most.

This "reverse redundancy" is contrary to the RCMP's own conclusions and defies the primary redundancy standards established by experts in the field of emergency service delivery. The safety of Nova Scotians should be the number one concern and consideration for this proposal should end now.
