administer the program and provide loans to small businesses and social enterprises, ensuring lending decisions are made in the community. Government partners with the Nova Scotia Co-operative Council to provide the guarantee and management of the portfolio.

Everyone is encouraged to use the BurnSafe map rules to reduce wildfire risks. The colour-coded map at www.novascotia.ca/burnsafe shows when burning is allowed or not allowed. The map is updated daily at 2 p.m. The same information is also available by calling toll free 1-855-564-2876.

Burning brush or campfires is illegal and unsafe between 8 a.m. and 2 p.m. on any day.

On April 25th, Environment Minister Margaret Miller dismissed two remaining appeals on the industrial approval provided to Alton Natural Gas Storage LP for the proposed brine storage pond in Colchester County. The environmental assess of the project was completed in 2007. The decision letters can be found online at <http://novascotia.ca/nse/issues/alton.asp>.

Government is repealing the 1928 Blueberry Associations Act. The act has not been used in many years and is no longer relevant. All matters associated with it are now dealt with through other pieces of legislation. "Last year, growers exported \$123 million worth of Nova Scotia blueberries and government announced \$1.08 million over three years to increase the amount of land for the blueberry growing industry. Blueberries account for half the value of fruit production in Nova Scotia.

and still be profitable? I wish I knew. Is it possible this company needs the volume to try and make their operation more efficient or sustainable? Very possible, as it clearly would have a negative effect on our operation

Is it possible that once the private company has established new clients they will then slowly increase their price? Possible that is business.

Is it possible a private company does not have to adhere to the same environmental standards? I do not know. However, what I do know, for example, is the Nova Scotia Dept of Environment mandated organics were banned from being land filled. They had to be composted. That is the law.

That is why Colchester County had to bring in those green bins everyone loves so much - to meet Government requirements. As a member of the Northern region waste board I get the information on how much and what each Municipality in Nova Scotia sends to land fill, how much they compost, and how much they sort and recycle. Low and behold, there are municipalities that do not have green bins. How can that be?

Are we to believe, you can have a municipality which includes at least one town, every single resident does their own composting? One of those Municipalities just happens to be the Municipality which sends their solid waste to the same private company which is offering to take our commercial garbage at a reduced rate. Do you think it is possible, the private company does not have to follow the same strict guidelines that a Municipal operation does?

I cannot honestly answer these questions. I will tell you is my opinion we must protect the investments made over the past 25

Mayor Bob Taylor and Mayor Bill Mills gave a presentation called "Working with a Common Purpose". They explained how the Town and the County continue to explore new ways to cooperate together. There is always more that can be done when it comes to regional cooperation and we as a council consciously seek out ways to share services. This doesn't stop with the Town of Truro our council also partners with the Millbrook First Nation and the Town of Stewiacke on many projects and committees.
