#### A new function called Perspectives.

Nova Scotia's open data portal marks its third anniversary with the release of new datasets and a new function called Perspectives. The portal can be accessed at [data.novascotia.ca](http://data.novascotia.ca)

Open data encourages research and innovation that can support the economic and social prosperity of our communities.

Several new datasets have been made available, including: details on Innovacorp's Acceleration Program awards for startups; school-based immunization data; surface water quality monitoring data; additional public opinion research. These new datasets will bring the total number of datasets on the portal to more than 540.

Perspectives included this quarter are: Citizen's Guide to Open Data; Innovating with Open Data; Understanding Complex Data: Ambient Air Quality and Informing with Open Data: Ticks and Lyme Disease.

To promote innovative uses of the data, the province is once again partnering with the School of Information Management and the Rowe School of Business at Dalhousie University to host the third annual Open Data Contest March 2 and 3 in conjunction with International Open Data Day. #### More Youth Choose Nova Scotia

Nova Scotia has had three years of positive growth in youth population after more than three decades of a trend that saw more youth leaving than coming to the province. "For the third year in a row, more young people came to Nova Scotia than left," said Finance and Treasury Board Minister Karen Casey. "We are pleased that this trend continues in the right direction and we will continue to monitor youth migration."

The figures are in a report by Statistics Canada. During 2017-18, 7,364 youth aged 15-34 came into the province, while 6,745 left.

The under 14 age group is also a key driver of the total number of people moving between provinces. The province saw 2,587 children coming here versus 2,039 who left, for a gain of 558. Youth aged 26-35 were the biggest source of migration from other provinces with a gain of 657 people, when compared with all other 10-year age groups. Nova Scotia's population was an estimated 959,942 as of July 1, 2018. This is a gain of 9,262 people compared to the estimate for July 1, 2017. This one per cent growth is the strongest in 34 years.

## "Poppy Box" Battle Settled

The "poppy box" battle which upset councillors, veterans, Tatamagouche Legion and many friends of veterans and their families has been settled. In the weeks leading up to Remembrance Day, the Tatamagouche branch of Colchester East Hants Public Library refused to allow the Legion to place poppy boxes in the branch.

After receiving concerns from Legion officials, area councillor, Mike Gregory, a retired RCMP officer brought the matter to council, and then participated in numerous meetings between the Legion and Library officials.

Library staff prepared a "Selling and Soliciting Policy", which was approved by the library board in September resulting in the denial to pace

poppy boxes within the branch. On November 27th, the board issued a directive for Tiffany Bartlett, CEO, Ruby McDorman, Chair and Lesley Brann, Head of Adult and circulation Services to meet with Legion officials.

On January 16, 2019, the board directed the policy to be amended to allow for donation of money boxes for non-profit, charitable and community-led funding raising initiatives. In her letter to council, Bartlett concluded, "the library prides itself on being community-oriented and upholding fair and equitable access for all". The change in policy is more inclusive and not limited to enhancing existing activities commemorating Remembrance Day.



## Raymond Tynes Appointed to Human Rights Commission

Raymond Tynes, Truro is one of two new commissioners appointed to the Human Rights Commission. The second appointee is Denise Mentis-Smith, Halifax.

Commissioners are appointed by an order of Executive Council. Responsibilities include the strategic direction of the commission and making decisions on human rights issues including referrals of complaints to boards of inquiry.

Tynes has been active for many years in the field of race relations. He served as the first African Nova Scotian municipal town councillor in Truro for 12 years and served as the African Nova Scotia school board member for four years. He has also served as the executive director of the Colchester Community Workshop, which offers programs to individuals living with intellectual disabilities. Mr. Tynes is a recipient of the Queen's Diamond Jubilee Medal and was presented with the Dr. Burnley "Rocky" Jones Human Rights Award in 2016.

Ms. Smith is a graduate of the Schulich School of Law, Dalhousie University. She was called to the Nova Scotia bar in 1996 and practices with the law firm Harris North Law in Bedford. Ms. Mentis-Smith is a noted speaker on human rights and issues affecting the

African Nova Scotian community.

Cheryl Knockwood, Sydney, who has been a commissioner since 2015, has been reappointed. She is a lawyer and works for the Membertou

First Nation as its governance co-ordinator. She has also taught Aboriginal and treaty rights at Cape Breton University at least twice a year.

Commissioners meet six times annually often at the Hal-

ifax office. However, they meet in a community outside of the Halifax Regional Municipality at least twice a year.
