Colchester Going to Saltscapes Expo

Devin Trefry has been busy lining up partners and what will be needed for a professional 400 sq ft display at Saltscapes Expo. At Exhibition Park, Halifax, April 12-14. According to his Action item submitted to council on January 31st, he reported Town of Truro and Downtown Truro Partnership has indicated a desire to partner with expressions of interest from Cliffs of Fundy Aspiring Geopark and Events Truro Colchester.

Trefry is proposing four 100 foot spaces to obtain greater regional impact. To ensure Colchester itself has a significant impact a 20'w x 10'd space is proposed to include: 10'w x 8'h static display featuring Colchester word mark and single, large, eye catching graphic; Two 50" high definition digital screens on stands featuring a collage of attractive video and still images from throughout the County; Literature rack featuring information on area parks, trails, and attractions. Pedestal tables featuring promotional items and a prize draw for a package promoting a variety of local products. Plants and other decorative elements may be added to make the space more welcoming.

Trefry's proposed budget includes: 10'x8' Tradeshow display, lighting, design \$3,000; Digital screens, stands and accessories \$2,200; Custom Video Production \$500; Promotional Material \$500; Exhibit Space (20'w x 10'd) \$2,700; Travel Expenses \$1,000 and Miscellaneous \$100 for a total of \$10,000.

Of the proposed investment, over half (\$5,700) would be for items that can be used for future promotional purposes (e.g. backdrop, digital screens, promotional video). The digital screens will provide an opportunity to easily change promotional messages for a variety of uses (e.g. at the NSFM Spring Workshop registration desk, promotion of the new Alert TC emergency notification program, recreation summer programs, etc.).

The tradeshow backdrop graphic may also be changed to suit a variety of needs.
