### **Launch of Woodlot Owners Survey**

As part of the ongoing work to help create a forest culture that balances forest stewardship and economic development, it's imperative that we engage and hear from private woodland owners across Nova Scotia.

Today, we have launched an online survey to collect input directly from private woodland owners. As they make decisions about how they use and manage their woodlands, we want to better understand their interests, values and motivations for land use, as well as management practices, to ensure they have access to information, programs and other resources that can help them meet their goals.

This initiative is a partnership between our team here at Lands & Forestry and the Forestry Transition Team. The results will inform the development and delivery of quality programs and services, improve information sharing and education, and support woodland owner leadership, networking and solutions.

If you are a woodland owner yourself, I hope you complete the survey. I also hope you encourage others in your communities and networks to do so either through word of mouth, by forwarding this email and/or through social media. Answers provided will be treated confidentially. Government has hired a professional research firm that will collect and analyze the data. Answers will not be tied to an individual's name or location, as they will be grouped with the feedback provided by others.

Anyone who wishes to complete the survey but doesn't have access to the Internet can call their local Lands & Forestry office for assistance.

Please also note, this survey is not available in French, however, we are hoping French-speaking woodland owners will participate. A French-

only focus group will be held.

### **Draft New Forest Management Guide: Public Consultation**

As you know, Government is committed to adopting ecological forestry in Nova Scotia. Work is underway to move to a triad model of ecological forestry for how we manage our Crown land forests. The triad model for ecological forestry is made up of 3 zones that work together: production forest zones, conservation zones and ecological matrix zones.

We are writing to provide an update on the work underway to review and revise the Forest Management Guide. A new guide will be an important part of the ecological forestry model. The Forest Management Guide project team has been working to complete a revised draft of the guide, which is now being called the Silvicultural Guide for the Ecological Matrix. The draft guide includes changes to how Crown land forests would be managed in the province in mixed-use areas (the ecological matrix zone of the triad).

We released the draft Silvicultural Guide for the Ecological Matrix for public consultation on January 20, 2021. We are sharing the draft guide, and supporting documents and information, with the public online at the following link: <https://novascotia.ca/natr/consultation/forest-management-guide-public-consultation.asp>. The consultation will be open for public comment for 30 days.

To keep the organization maintaining its successful path meant reinventing major programs like the Parrsboro International Plein Air Festival, an outdoor painting event known to be the most successful in Canada which annually has drawn artists from across North America.

series of art courses, had to be reorganized in its presentation and format. In the past the campus has drawn artists and instructors from several nations and international locations.

Largely due to her innovative

mind and tireless work ethic, of staff and community volunteers these programs were reinvented permitting them to be successful during the pandemic. Plans are underway to develop the 2021 programs.

## Training Fire Fighters

At its meeting on February 17 Cumberland Council discussed the importance of fire fighters being trained in mask fit training required to be permitted to attend emergencies as medical first responders, given the rural nature of the municipality and the length of time it can take for EHS to arrive.

The municipal fire services coordinator and deputy mayor will work together to write a letter to the province to request improvement the current policy and request action be undertaken to alleviate the current situation regarding EHS response times due to shortage of paramedics.
