63rd General Assembly to Open March 9

The second session of the 63rd General Assembly was prorogued on Friday, Dec. 18, 2020. The third session of the 63rd General Assembly has been rescheduled and will open officially at 1 p.m. on Tuesday, March 9, at which time the Lieutenant-Governor of Nova Scotia will read the speech from the throne.

Order of Nova Scotia nominations

Nova Scotians are encouraged to nominate an exceptional member of their community for the Order of Nova Scotia. Now in its 20th year, the order is the province's highest honour and recognizes outstanding citizens for making significant and lasting contributions to their communities. Past recipients have included a Nobel Prize Laureate, academics, athletes, volunteers, advocates and artists.

Nominations will be accepted by mail, fax or email until March 19. Nomination forms are available at Access Nova Scotia centres, Province House in Halifax, MLA and MP offices, municipal offices and online. 1,999 Covid Tests completed

As of February 12, Nova Scotia had nine active cases of COVID-19. No new cases are being reported.

Nova Scotia Health Authority's labs completed 1,999 Nova Scotia tests on February 11. There were 1,006 tests administered between February 5 and 11 at the rapid-testing pop-up sites in Amherst, Cole Harbour, Halifax and Tantallon. Since Oct. 1, Nova Scotia has completed 177,461 tests. There have been 501 positive COVID-19 cases and no deaths.

Skier dies at Ski Wentworth

On February 6 Cumberland District RCMP responded to a report of a missing man last seen skiing earlier in the day on the ski hill in Wentworth. While police were en-route, the man was located off trail by Ski Patrol representatives of the recreational facility. The man was brought to a first aid tent and seen by EHS, he was not able to be revived. The 43-year-old Halifax man was pronounced deceased at the scene. The preliminary investigation indicates the death not to be suspicious and includes assistance from the Nova Scotia Medical Examiner's Service.
