Notice of Intent to Amend the By-laws

The Truro & Colchester Chamber of Commerce will vote on By-law Amendments at its Annual General Meeting on March 9, 2022. During a Board of Directors' meeting held on Sept. 8, 2021, the Board passed the proposed amendments.

The proposed revision is to reduce the minimum number of non-executive board members from 10 to six people.

Present version - ARTICLE V - BOARD, OFFICERS, EXECUTIVE DIRECTOR

5.1.1 The president, first vice-president, second vice-president, treasurer, the Chamber solicitor and at least ten (10) other members shall be elected from among the members each year at the annual general meeting and shall form the Board.

Amended version - ARTICLE V - BOARD, OFFICERS, EXECUTIVE DIRECTOR

5.1.1 The president, first vice-president, second vice-president, treasurer, the Chamber solicitor and at least six (6) other members shall be elected from among the members each year at the annual general meeting and shall form the Board.

Colchester Council shelves Vaccination Policy for Staff

At the February 24th monthly meeting of Colchester council the report and recommendation of Council Committee Meeting Held on February 10, 2022 were approved which included: Community Energy and Emissions Plan as presented; Requests to Purchase Recreational Lands, Princeton Heights was approved for the Evergreen Drive property (PID 20436044) and that the Spruce Drive property (PID 20259727) be retained by the Municipality; Low Income Municipal Tax Assistance Program Policy was approved as presented. Another items from the committee meeting included the Council Proceedings Policy Amendments for Council Proceedings and Committees Policy was approved as presented.

Covid-19 Mandatory Vaccination Policy development which has been ongoing for two years, council decided with mandates ending in March, it would not adopt the policy,

but know that after a lot of staff time and research had gone into the proposed policy. The policy had been approved at the committee meeting on February 10th, but the rapid decline in cases and hospitalizations, and government's mandates would end on March 21, councillors decided to put the matter on the shelf. Solicitor Dennis James was asked on several occasions for advise. Essentially instead of making a decision should the pandemic come back with a resurgence, council decided to kick the ball down the road for another day.

Truro Horsemen's Club seeking back taxes to 2019 has placed council in a rough spot from what they would like to do, compared to what they legally can do. The Municipal Governance Act (MGA) prohibits council from making a decision to accommodate the club's request. It is expected the matter will be back on the table to perhaps find a way to give the Horseman's Club a special grant, with


