Bronwyn Duffy of Bible Hill is on one of four new judges have been appointed to the provincial court effective, February 3. The other three included: Jillian Barrington, Sydney; Jill Hartlen, Hubbards and Bryna Hatt, New Glasgow are Nova Scotia's newest judges.

Bronwyn Duffy was a partner with MacIsaac, Clarke & Duffy in Stellarton. Her practice included federal prosecutions as agent counsel for the Public Prosecution Service of Canada, being a town solicitor, residential and commercial real estate, and municipal law. She is actively involved in her community, particularly with youth academic and sports initiatives. She was called to the bar in 2010.

Jillian Barrington practised with Sheldon Nathanson Law Office in Sydney, where she focused on criminal and family law. She has also represented children and guardians as a court-appointed lawyer in matters with Mi'kmaq Family and Children's Services of Nova Scotia. She was

Bryna Hatt was a lawyer and President of Fraser Hatt Law in Port Hawkesbury, where she practised Indigenous, labour and employment law and conducted independent workplace investigations. She has worked with First Nation governments and tribal councils on matters of aboriginal rights, labour and employment, and constitutional law. She has also been an adjudicator with the Nova Scotia small claims court. She was called to the bar in 2008.

Healthcare Clinics Tested at Community Pharmacies

The Medicine Shoppe, 664 Prince St., Truro is one of 12 pharmacies, from across the province, chosen to pilot the Community Pharmacy Primary Care Clinics program to deliver more healthcare services at their local pharmacy. The Community Pharmacy Primary Care Clinics program will be piloted in 12 pharmacies across Nova Scotia, with more locations expected in the spring. Appointment opportunities began on February 1.

Pharmacists in these clinics will have dedicated time to see patients with common illnesses and people who are on medications for chronic diseases like diabetes,

and cardiovascular and lung disease. They will also provide care for strep throat, including testing, diagnosis and treatment, something that has not been available through pharmacies previously.

Pharmacists at the pilot locations will also be able to prescribe and manage medications for diabetes, cardiovascular disease, asthma and chronic obstructive pulmonary disease (COPD). The pharmacies under this pilot will receive additional funding for providing added care, including assessing and prescribing for 31 minor ailments such as minor joint and muscle pains, eczema, cold sores and heartburn.
