Therefore, with this plan, 1 $\frac{1}{2}$ to 2 million parents would be choosing to leave the workplace and return home. That would open up 1.5 to 2 million jobs for the unemployed and reduce Employment Insurance & welfare payments. So this will not require any tax increases to implement.

With a parent at home, you will have less delinquency, safer streets, and stronger communities.

Do You Know What To Do?

You are in the mall, and suddenly the shopper next to you collapses. On the wall is an automated external defibrillator (AED), a device that can shock a heart in cardiac arrest back into a normal rhythm. Although sending electricity through an unconscious stranger's heart may seem like something best left to a professional, AED's can be used successfully by a passerby with no training. And the sooner the better! AED's are easy to use and survival rates are higher for people treated within the first minute.

What to do:

Call 911 to get help moving in your direction. Have someone start CPR. Clear the area of flammable liquids and water.

Open the case and turn the AED on. This will activate

voice commands. Remove all clothes from the patient's

Stick the adhesive pads to the person's bare chest according to the diagram on the pads/machine.

The AED will analyze the heart rhythm and in less than 8 seconds determine if a shock is needed. No one should touch the patient during analysis. If the AED indicates, keep everyone clear and press the shock button.

After the shock continue CPR until you see signs of life. The AED can shock as many times as needed. If the AED says no shock advised, continue CPR until help arrives.

Don't worry! You can't accidentally shock someone AED decides that the person is not in cardiac arrest, it simply won't shock them.
