**April, 1995 (Vol. 2, No. 1)** - Bass River Learning Center celebrates 6 graduates. Layton's General Store celebrating 125<sup>th</sup> Anniversary. Changes to fishing regulations a source of frustration. Arthur & Alice Pugsley win Cumberland/Colchester Counties Woodlot Owner of the Year.

## Colwell Names 3 Member Interim NSPE Board

An amendment to the Nova Scotia Provincial Exhibition Commission Act will give the Agriculture Minister the authority to appoint members to the board of directors. When passed the amendment will allow Agriculture Minister Keith Colwell to appoint a three-person interim board to replace the current board, and bring stability to the commission.

Mr. Colwell has identified Bruce Kennedy, chair; Cameron MacEachen; and Gary Muise and will assume their new duties when an amendment to the NSPE Commission Act passes in the legislature. "All three have experience as directors of boards," said Mr. Colwell. "They are dedicated to defining the business opportunities for the Nova Scotia Provincial Exhibition and for the province."

Kennedy has operated a family business in Bible Hill for 35 years serving as a member of the Business Advisory Council for Nova

Scotia, is former president of the Provincial Association of Convenience Stores in Nova Scotia, as well as the Truro Harness Horse Owners Association.

Mr. MacEachen is a graduate of St. Francis Xavier University and has worked as a chartered accountant for the past decade. He and his family have been involved in the harness racing industry for nine years. Mr. Muise has been vice-president of operations with the Grafton Connor Group for the past 11 years. He sits on the board of the Restaurant Association of Nova Scotia.

Mr. Colwell also announced the tender for the audit has been awarded to KPMG with an expected completion in early July. Colwell is insistent the NSPE is self-supporting, has long-term stability and is able to help grow the Nova Scotia economy. A job posting for a permanent general manager for the Nova Scotia Provincial Exhibition is expected within a few weeks.
