### What's Inside Regarding the Tragedy in Portapique

The Shoreline Journal has attempted to provide a summary of events evolving from the April 18 & 19 tragic murders in several communities in Colchester, Cumberland Counties and the Municipality of East Hants. An index of the special coverage follows:

**PAGE 1:** As noted above pictures of 22 victims

**PAGE 12 & 13:** A collection of photos from Great Village and various shrines along Highway #2 in Highland Village, and Portapique. Several photos were taken at the former church Portapique, which was established by Cees Van den Hoek, who lived in the area, owns the former church as well as Great Village Antiques Exchange, in Great Village.

**PAGE 15:** A photo of Great Village Fire Hall, which was used as a staging area by RCMP and EMO, plus several stories including "It all started in Portapique", as well as a request by area residents and families of victims for their privacy to be honoured. Another article provides a summary of various events which have evolved during the following week.

**PAGE 16:** Among the stories on this page are Messages of Condolences from area elected officials, a short

outline of the Assailant's Troubled Past; how the media has descended on Nova Scotia and that a major lawsuit is probable.
