The Mobile Breast Screening Clinic will be in Bass River at the Fire Hall on Nov. 16th and 17th. Women 40 years and over are encouraged to make an appointment, as long as it has been 1 year since a previous mammogram. One of the best ways to protect and care for your breast health is to have regular screening mammograms (breast x-rays). The criteria for screening includes no breast implants, no personal history of breast cancer, minimum of 1 year since last breast surgery and a minimum of 6 months since last aspiration. Appointments can be booked by calling 1-800-565-0548.

Credit Union Reduces Hours

Residents of the Fundy Shore area of West Colchester are trying to come to grips with the announcement the Community Credit Union branch in Bass River will soon be operating on reduced hours. The announcement shocked the community, who are upset with the inconvenience and the negative on area business.

Commencing November 15th the credit union branch in Bass River will commence operating at 12 hours per week. Open

hours will be 1:00 to 5:00 pm on Tuesday, Thursday and Friday. The branch will be closed on Monday and Wednesday.

Executives of the credit union have been approached to attend a public meeting, but have declined the invita-

On October 11th staff at the branch were informed of the amended hours and were asked to immediately start advising customers. The Board of Directors and Management of Community Credit Union of Cumberland Colchester prepared a letter to be distributed to members advising then that effective November 15th, the branch in Bass River would be reducing its open hours to 12 hours per week.

When contacted by the Shoreline, Darrell J. Kuhn, CEO who works out of the Amherst Administrative Office said the branch has been operating at a loss for several years and it's unfortunate we have to take this action. He said management has tracked usage times and have selected open hours to best reflect peak usage times.

To guage the reaction to the announcement, the Shoreline sent an email to subscribers, contributors and advertisers asking five questions. Here's a response from one subscriber, "Although I do not live in the Bass River area, I feel very strongly regarding essential services such as banking being accessible in small communities. To take it away could contribute to the demise of the community".

95% of respondents to the Shoreline's online survey said members and residents should lobby to have hours reinstated; while 63% or those replying said they are considering moving their business elsewhere. As to usage of the branch 35% use it regularly; 30% occasionally, and 35% don't use




