I would like to deal with the facts in this situation.

Here are some facts about the WCUA operations over the past few years:

- Ice rentals in Debert for minor hockey went from 981.5 hours in 2011/12 to 878 hours in 2012/13 to 453.5 hours in 2013/14. (This is the major cause of the projected deficit)
- Skate sharpening went from 871 pairs in 2011/12 to 641 pairs in 2012/13 down to 559 pairs in 2013/14.
- In 2011 the WCUA had a significant reserve in the bank and had been carrying a reserve fund for some time.
- WCUA board of directors is projecting a \$53,000 deficit for the 2015/16 season.
- The County paid \$72,500 in capital cost last year, no operating cost.
- The County also paid \$9,000 in insurance cost last year.

The arena did have a contract with a local company to use the facility for storage during the summer months. This agreement has ended and so has the revenue.

The County Recreation Department set aside \$38,000 in 2014/15 for all three arenas to be used for new program opportunities. Along with this our county Rec department also made up and distributed information packages to the local schools in the area. They also purchased ice time for schools, public skate

times and figure skating.

The fact is Colchester County Council has always supported our local arenas and will continue to do so. We can debate the merits of the RECC until the cows come home but the fact is it wouldn't help the situation the WCUA finds itself in. Personally I'm going to move forward and try to help find new revenue streams and funding for our rink.

I sure hope some of you want to help because I know for a fact it's going to take everyone getting involved and supporting our rink to turn this around. We can stand around pointing fingers at the causes all day or we can put our heads together and come up with some solutions. Which do you think will be more productive?

In closing I would like to say thank you to the Board of Directors and the staff of the West Colchester United Arena. For decades you have poured your heart and soul into this facility and you deserve the gratitude of the entire community.
