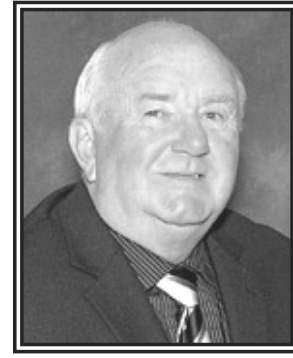

Cumberland Council to study Hydraulic Fracturing

Two items were covered in council's October 3rd, in-camera session which preceded the public session at 6:00 pm. Approval was given for the special council held on September 26th, which had dealt with financial matters. One unsightly/dangerous property approved for removal.

Council's financial sustainability strategy was discussed and approved by motion. It will review current financial

position and health and where we need to be in the future and how to get there. First reading of the amendment to the MPS/LAND USE BYLAW was approved.

Council's program and services review process was discussed and approved with transfer stations used as a discussion item. Six programs will be initially looked at: transfer stations; LED streetlights (in progress); police service review; capitol from revenue; governance review and fire service protection.

Day was discussed with each service covered. The next council meeting will include election of deputy warden for the next year. Information items included an update on tax collection and tax sales; tourism strategic planning committee update, NSFM board report, finance department report and the Springhill pit pond trail project.

Cumberland Council Continues Fracking Study

Four items were covered at Cumberland council's in-camera session prior to the public session on October 17th. Mike Johnson, EMO coordinator provided an update on the Oxford sinkhole. The hole is still there and is being monitored and a decision on next step forthcoming.

A short discussion was held on two stream recycling as it pertains to the commercial sector and to include them in the process. Discussion on the Wheeler

report on Fracturing continues with each session getting deeper into the subject. The public can always attend council and listen to the discussions if interested!

Borrowing resolutions for the Pugwash water project and Parrsboro waste water project were both approved by council. The municipality's flag policy was approved with option 2 which will have a designated flag pole at each service center. The protection from second hand smoke policy went back to staff for

another look with designated smoking areas a stumbling block.

The health and safety policy was approved by motion as were five grants to organizations. The Southampton Fire Department washroom facilities were part of the presentation by the municipality's fire service coordinator. A further presentation will be made to council in the near future to deal with the issue which has been going on for a few years.

Progress Being Made on Physician Recruitment

(ED NOTE: It might seem like old news, but the same day the last issue was published, Cumberland councils were holding one of their joint meetings).

On September 26th, it was the municipality's turn to host the joint meeting of Cumberland councils. It was held at the Joggins Fossil Centre. The agenda included introduction; a reminder no decisions; supper, tour of the center and discussion on inter-municipal cooperation.

After introductions we had

a meal catered by McPuffins, a new restaurant in Joggins. A great meal supplied by a local small business that employs local citizens. That's a win-win situation. Most attendees each donated twenty dollars each to a local food bank to be decided by host municipality.

Under inter-municipal cooperation we discussed grants to organizations and ways to streamline the services we provide. The regional property assessed clean energy (PACE) program was discussed and it appears all three municipalities will be includ-

ed.

An update on the CJSMA inter-municipal agreement was briefly discussed with indications it is moving along. A discussion on cannabis and related bylaws and policies followed with emphasis on all three municipalities having a similar plan for all of County. At present Cumberland has a second-hand smoke bylaw in progress and Amherst has a nuisance bylaw in progress, Oxford is beginning and already has a no smoking policy in town. The challenge for all will be enforcement.

Buildings Program," said Sandra Currie, FORCE's facilities manager. "Today's announcement will enable us to demonstrate another technology at our facility and to further contribute to Nova Scotia's clean energy future."

The Town of Amherst will use the funding for a project at the Amherst Stadium. "The Town of Amherst is pleased to be awarded the opportunity

to produce renewable energy under the Solar For Community Buildings Program. Municipalities have a significant role to play in the shift to a clean energy economy that will reduce emissions while keeping more money in the local economy," said Mayor David Kogan. Representatives from all three projects gathered in Springhill for the announcement.
