## Today's Nurse wins Growth Award

This award recognizes a business that has been in operation for more than two years demonstrating growth in a measurable way such as expansion, increased customers, new employees, new products, etc.

Today's Nurse Inc. in Truro has been in operation for just over three years, growing exponentially during that short period of time. The home support agency provides all levels of care to individuals in their own homes such as home services, personal care as well as nursing care on a private basis.

The business opened in April 2016 and at the end of the first quarter, they had just five clients and seven casual employees. Pushing to succeed despite the

slow start, owner Sherri Smith persevered and today the business has grown dramatically to employ 35 caregivers and four on call.

The current business model provides back up support in assisted living, as well as long-term care facilities to help ease the burden caused by staff shortages.

The support agency has plans for growth in the future aiming to eventually branch out into neighbouring communities as staff recruitment challenges improve. The business is dedicated to deliver highest quality home care while preserving the dignity of its clients, allowing them to be in control of their well-being in today's changing healthcare environment.

## **G-Man Waste Removal wins New Small Business Award**

This award recognizes a Truro or Colchester business operating for more than one year and less than two years that has gained an expanding positive reputation. The business must have shown innovation and offer unique products or services that go the extra mile in the local marketplace.

G-Man Waste Removal opened its doors in 2017 by primarily serving commercial businesses with their container needs. Originating in Millbrook First Nation, it has since expanded into curbside collection for the community. As one of only a few First Nation owned and operated waste removal companies, requests from other Mi'kmaq communities soon started arriving. This presented the opportunity for other waste related projects such as, community outreach and education, waste audits and community wide waste diversion projects that include door to door education and delivery of waste management systems.

G-Man started with 14 commercial dumpsters and has grown to 44 servicing Millbrook and surrounding areas providing commercial and residential hauling of

compost, recyclables, and landfill materials as well and any construction and demolition materials.

The owners take pride in being a family run business that focuses on relationships with clients. They won a 2018 Mobius Award in their first year of operation. The business operates under a strong ethical environmental conscience ensuring relationships and compliance with landfills and other facilities is at the forefront even if this isn't always the easiest or most economical choice in the short term. Their commitment to the environment and future generations is part of their mandate.

During its short time in operation, G-Man, in partnership with Mi'kmawey Green Communities, was able to implement indoor and outdoor recycling systems to improve diversion rates in their home community. To date this program has been well received and has increased waste diversion and compliance with municipal guidelines. Similar projects have also been completed in other Communities due to the success of the Millbrook program. This system has been called the gold standard by the industry and municipalities.
