100-Year-Old Veteran Remembers the Fallen

Dear Editor,

I lost my right arm on October 18, 1944, while serving with the Loyal Edmonton Regiment in Italy. I was staked at a farmhouse that had a children's treehouse located nearby. In the treehouse was a

sniper who kept shooting at our boys. A tank then came which shot out shells, the shrapnel hitting my right arm.

When I returned home from the war, I joined The War Amps and have been a member ever since. This Association

was started by First World War amputee veterans to help each other adapt to their new reality as amputees.

Having just recently turned 100, I am reflecting this Remembrance Day upon all those who served in my regiment and never returned home. Their absence weighs on me and it is essential that we keep their memory alive. I take comfort in knowing that The War Amps and its young members will continue to keep spreading the message long into the future.

The sacrifices of those who served (and continue to serve) deserve to be remembered and honoured. Each Remembrance Day serves as a poignant reminder of the tremendous price paid by these brave individuals. Their

Homeowner Ordered Off Her Property

On the afternoon of Wednesday, October 11, lifelong Truro resident and homeowner Karin Irving, was ordered off of her own property by a member of the Truro Police Service. Irving had rented out her home for the months of August and September. The tenants had not paid rent since August.

They brought a large dog into the home in violation of the lease. And they changed the locks. In accordance with the Notice to Quit issued by Irving, the tenants were supposed to have vacated the premises no later than October 8. After providing the requisite 24 hours notice, Irving, along with several family members, a local real estate agent, and four Truro Police officers, visited the property on October 11 in order to enable the realtor to assess the property for sale, which is within their rights under the terms of the Nova Scotia Residential Tenancies Act.

When the tenants refused them entry, the police officer ordered Irving and her entire party off her property, saying this wasn't a police matter but a civil matter. They could not

allow her to escalate the encounter for the safety of the current occupants - the squatters - to gain access to her property and instead issued the verbal trespass in response.

Irving, who rented her small home to earn some money to get her through the coming winter, is now homeless and living on her parents' sofa while her former tenants, now squatters, Shane Meinema and Ryan Becker, both from Ontario, enjoy her home, along with, Marissa Renaud who has moved in full time with the 2 original lessees. Irving has reason to believe damage has been done inside the home.

"I've worked hard all my life to afford to buy a home. I pay my mortgage. I pay my taxes. And I'm literally homeless," said Irving. "I can't even get my winter coat from my garage because they changed the locks."

And neither the police nor the Tenancies Board will do anything to help me. Aren't these folks supposed to uphold the law? A frustrated Irving added, "These people are now trespassing in my home. But I'm the one who got kicked off my property!"

Irving had a hearing sched-

uled with the Nova Scotia Residential Tenancies Board on November 29th. But

in the meantime, she submitted for a formal Notice to Quit, which the Board's representative said is invalid due to a small mistake in filling out the form requiring her to start over.

"With the current housing crisis, it is understandable that no public officials want to be responsible for putting people out in the street," said Kelly Sanderson, Irving's sister. "But my sister is currently in the hospital because of the stress this has caused her. This is just so wrong. And it's made worse by the complete absence of support from the authorities who are supposed to protect us."

Several local officials have taken up the cause, but all get the same story from the police, that it isn't a police matter. Exasperating the issue is the difficulty accessing the tenancy board as in Truro this handled through Access Nova Scotia.

The head of Nova Scotia Residential Tenancies Board has reached out and confirmed that the initial Notice to quit was rejected to an error on the form.

selflessness and courage continue to resonate, and it is our duty to ensure that their legacy endures.
