Tom Taggart Candidate for Councilor - District 10

What in your opinion are the three most challenging issues facing the Municipality?

Jobs, declining population in rural areas and provincial downloading.

If you had the sole responsibility to solve them what would you do? I believe that the best way to create jobs and end the population decline in our rural communities is to develop the Debert Air Industrial Park. To date development has been difficult due to Provincial Government supported requirements for excess and expensive archeological clearance. These requirements are the most stringent of any province in Canada and I am told the only person who can bring them in line is the Premier. It is critical this industrial park be positioned to take advantage of the spin off from the ship building contract.

As for downloading we need to work closely with the Union of Nova Scotia Municipalities to lobby and negotiate with the provincial government.

What is the most difficult topic you expect to come before council in the next year, which will have voters upset? Atlantic Industrial Services has made application to Dept of Environment to release approximately 4.5 million liters of treated fracking fluids into the municipalities waste water treatment plant in Debert and thus into the river and on into the Bay of Fundy. I have been told by an anti-fracking group in Tatamagouche there are dangerous chemicals such as uranium in these fluids. You can be certain we will get evidence from the folks at Atlantic Industrial Services who claim there is no danger. To me it is very clear. IT IS NOT WORTH THE RISK. I am confident council will see it the same way.

Since rural areas are declining in population and the residents are getting older, how will you help community groups in your district to develop plans to bring younger families to your electoral district?

I will continue to work with and support local community groups as they work to maintain our community centers, parks and recreational facilities. However I believe to grow communities and encourage young families to put down roots we need good paying stable employment close to home. Once again our best opportunity for those jobs is the Debert Air Industrial Park.

Why do you think you are the best candidate to represent the residents on Municipal Council?

The past 4 years as councillor for District 10 have been an absolute pleasure. The experience has been both rewarding and educational. Your council representative has 2 main responsibilities; First to the residents of district 10 and second to Colchester County as a whole. I have worked hard at both. I have worked to satisfy and resolve all local issues, whether from individuals to community issues to County issues.

The past four years have given me the experience needed to represent you well in what most certainly will be challenging times ahead. It is my hope I have proven to you I can stand and be heard on the issues affecting district 10. I am not shy about voicing my opinion and sometimes asked the difficult questions needing to be asked gaining the respect of my fellow councillors, which is very important when I am asking for or debating issues which benefit our district.

I have been very active as your councillor. I am vice-chair of the Unsightly Premises Committee; I sit on the Flood Advisory Committee and the Planning Advisory Committee. As well on the provincial level I have been fortunate enough to be selected as a member of the Sustainable Practices Committee. What types of businesses do you think are most appropriate for your district and what will you do to attract them? Over the past 10 to 15 years agriculture has had a very significant impact on and created many jobs in our district. I will do all I can to support the farmers and to encourage all to buy local. I also believe due to the very persistent work of many entrepreneurs our tourism has increased. I will continue to support those folks and to raise the profile of our shore. However, it still comes back to the Debert Air Industrial Park It is CRITICAL we get the park in a position to take advantage of new industry wishing to re-locate or build their business in Central Nova Scotia

What are the most critical problems being faced by your constituents? Most critical issues are good jobs and strong, healthy growing communities.

If you are elected to council, how will you communicate with residents to understand their problems and what you are doing to solve them?

Over the past 4 years I have been fortunate enough to write a report from council in the Shoreline Journal. I hope to continue. As well, I have begun a Facebook page. Facebook is quite new to me but does appear to be an effective way to get out a message. Therefore, I will continue after the election to use this to communicate. need drivers and sorters for pickups and counting. Your children can also be a big help, as long as they can count to 100! It is always a good idea to teach your children from a young age about volunteering.


