**DISTRICT 10** voters have two candidates to choose as their representative for the next four years. Tom Taggart, a real estate agent, and incumbent councillor who has served on council for the past four years. He is

opposed by Doug Cooke, retired, who served on council for 22 years and was defeated by Taggart in the 2008 municipal election.

## Members Support Board's Decision to Close Branch

The Board of Directors of Community Credit Union confirmed the scheduled Special Meeting of the General Membership was held Thursday, August 30, 2012 at the Wandlyn Inn, Amherst, NS. The purpose of the meeting was to provide additional financial information concerning the closure of the Bass River branch. This meeting and information was requested by the Bass River committee members. The general membership present resolved that they had confidence in the Board's decision to close the Bass River branch.

Board Chair Charlotte MacVicar confirmed "we were

very pleased with the meeting and in particular the vote of confidence from the general membership in our decision to close the Bass River branch. The overwhelming support from the members in attendance demonstrated that the action taken by the Board for the sustainability of the entire Credit Union was appropriate."

Chair MacVicar further stated that "the Board has reached out to the Bass River Committee on several occasions to meet and discuss their very recent proposal and we are hopeful that this will happen in the near future. We were, however, disappointed that the committee

members opted not to attend the meeting they had specifically requested.

President and CEO Darrell Kuhn reiterated MacVicar's comments "this has been a very difficult matter for everyone, including our Board and the Bass River members. Unfortunately the financial results and economic and demographic challenges have necessitated this decision." Kuhn further stated: We look forward to discussing the proposal received from the committee."

Community Credit Union has three branches, in Truro, Amherst, and Bass River with over 9000 customer - members and assets of \$85 Million.
