Deb Howell's Life Changed in an Instant

Debert: Deb Howell's nightmare began on Feb. 10th, 2014. One minute she was a healthy 57 year old, working two jobs, as a house cleaner and employee at Masstown Market, enjoying life and able to walk 5km/day,

and then all at once her world was turned upside down.

"I walked the dog as usual and then came in and sat down to watch a little television," says Deb Howell. "Soon it was time for bed, and that's when I realized I

couldn't get up."

Deb's husband rushed her into the Emergency department right away and doctors were baffled by her condition. Xrays showed there were no bones broken and she was referred to a specialist in New Glasgow.

\$15,000 Raised at Fund Raiser for Cooke Family

The field behind Faith Baptist Church in Great Village was bubbling with good food and fun times on August 23rd, as the extended community came together in support of Brent Cooke and his family.

Forty-seven year old Brent Cooke suffered a massive stroke in May, 2013 and has been in the intensive care unit at the Truro hospital ever since. He is paralyzed from the neck down.

A \$45,000 wheel chair was generously donated to Brent but modifications costing

about \$15,000 are necessary. This is when the community event, sponsored by Great Village Baptist Church, came to life. The main event for the day was a ball tournament, with a bake sale, bbq, dunk tank, bouncy house, mock jail and more.

Many area businesses generously donated to the fund raiser including: Masstown Market, KFC, Classic Rentals, Great Village Wilson's, TRA Cash & Carry, Debert Hospitality Center, Colchester Bouncy House Rental.

Members of the community pitched in with baking and

donating auction items.

Family spokesperson Sonya Barnhill says an amazing \$11,800 was raised that day and since then more donations have come in bringing the total up to the goal of \$15,000.

"Brent's family has been completely overwhelmed by everyone's generosity. It is so hard to find the words to express our thankfulness and to describe how this has touched our hearts. It has been an extremely difficult time and to have this financial burden lifted from Shirley, Brent and family has been an incredible blessing. Not to mention, the wheelchair will give Brent some independence, which is the greatest gift of all," says Sonya, Shirley's sister.

The wheelchair is currently undergoing the necessary modifications.

The family sends a huge thank you to Faith Baptist Church and its members for hosting the event and to everyone who donated their time, food and prizes, and to those that came out and showered love and support on the Cooke family. "We thank you from the bottom of our hearts," says Sonya.
