such equipment (County's Wastes Water Treatment Facility has very similar equipment) believe the issue could be resolved with the replacement of the aerators. Envirosystems however explains it has more to do with the Ph levels in the waste water holding ponds getting to high and thus creating an odor.

Controlling Ph levels is very inexpensive and extremely unpredictable, they seem to be able to get out of control in a very short period of time and take a considerable amount of time to get them back under control. I'm familiar with odors from high Ph levels from our experience with the county waste water facility in Lower Truro.

One of the main factors in that issue was a certain contaminant entering the system which shouldn't have been there in the first place which was causing spikes in the Ph levels. The contaminant was removed. The other major component to resolving this issue was the replacement of outdated aerators. This was an investment of several million dollars of taxes payer's money on the county's part.

The end result is we have residents who can once again BBQ on their back decks and enjoy their yards without being forced into their homes with the windows shut due to the bad odors in the air. We also have one of the most efficient state of the art waste water treatment facilities in all of Eastern Canada. A very good investment when you consider how clean the end product really is and where it is going.

With residents from Belmont, Crowes Mills and the Cross Roads area still experiencing odors after all these years it's now time Envirosystems committed to solving their problem. This will no doubt be an expensive investment for the company to upgrade their facility in Debert but at the same time they will be investing back into the community they chose to be part of. No one's quality of life should suffer over an issue which to my understanding is 100% fixable.

As I noted at the beginning Envirosystems operates under a permit issued by DOE. The permit is issued for several years and I believe the one they hold currently is still good for a few more years. It was explained to me by a DOE representative this way, even if DOE wanted to try and force the company to make upgrades to the facility they couldn't do so until the existing permit expires and a new one is applied for by Envirosystems.

This issue has been ongoing so long some residents have quit complaining about it due to the lack of action over the years. Please don't quit calling myself and Envirosystems when this odor arrives in your yard. Each incident needs to be documented with the time and date in order to keep an accurate record of when the smells occur. The company believes these are isolated incidences but considering the amount of calls I receive on these odors it appears to be at least two or three times per week. It all depends on the air currents as to who will call on any given day.

Council has requested Envirosystems appear before council for a presentation and a talk around how we are going to resolve this. Once this date has been set I will be notifying area residents so they can attend this presentation and hear the facts from the horse's mouth.

Some of the other issues I have been dealing with the past four years are as follows: Heavy truck traffic on Plains Rd from Dakota Rd through to the intersection of East Village Rd and the #4 Highway. Once again this is a Provincial matter but the department in charge of correcting it refuses to acknowledge the problem even exists. Many independent truckers take this route rather than going around exiting at the Debert Tim Horton's exit because it is approximately 9 km shorter to reach Lancaster Dr for example. The truckers get off the #104 at Station Rd in Great Village and come across the Carrobie Rd and then onto Plains Rd.

There are sections of Onslow Rd in the vicinity of the Onslow Junior High School that have been in disrepair ever since the new sidewalk was installed. Once again it is difficult to find a department who wants to take ownership of this issue.

The Debert Airport and Business Park play a huge role in what I do as a councilor. The potential for job growth and the future prosperity of our County lies within these two entities, in my opinion. Our first steps will be to secure the Airport with new fencing and the preparation of new hanger sites. One of the 5000 foot runways needs to be resurfaced as well. I would like to see us secure an anchor company or organization for the Airport to help with revenue moving forward rather than investing only tax dollars.
