## Council to Form Cannabis Ad Hoc Committee

At the request of Councillor Boutilier, Colchester will form an ad hoc committee to deal with Cannabis issues. In the committee's composition, Boutilier at the council's committee meeting on September 13th, asked for the committee to include at least two councillors and one staff member. Names will be collected by the nominating committee who will present a report at the August 27th monthly meeting.

In asking for an update on Truro Heights Playground, Deputy Mayor Masters was informed by Craig Burgess, Director of Recreation Services, the material will be on a truck by September 24th and will be installed by staff with an opening in October.

Big Brothers Big Sisters, who have purchased Molly's Dairy Bar on Route 311, requested and were granted tax exemption status on the property effective in the 2019/20 taxation year on motions by Councillors Boutilier and Parker. As a commercial property, it generated \$7,551 in commercial tax. With the construction of an 24 x 45 foot addition the value of the tax forgiveness is estimated to be \$4,500 per year.

An item dealing with mowing ditches in Brookfield

was tabled until Councillor Stewart was in attendance. He missed the committee meeting, because as president of Nova Scotia Federation of Municipalities, he was attending meetings in Annapolis Royal.

Hidden Valley Drive, a County-owned street, will get paved this fall. Council decided to award the tender to Will-Kare Paving & Contracting in the amount of \$135,000 excluding HST to complete the repaving of the full length of Hidden Valley Drive. The work would be completed in October.

Original plans were to do half this year and the remainder next year, but the prices submitted for this year's half were significantly below budget, council decided to complete the project this year. Three bids were submitted: Will-Kare Paving & Contracting, \$55,000; Basin Contracting, \$56,400 and Dexter Construction, \$67,850.

With a two year plan estimated to cost \$350,000, council decided to resurface the entire street this year at a cost of \$135,000. The remaining half of the street, approximately \$80,000, was more expensive because there are more driveways, manholes and intersections involved.

## Colchester County Finally Buys Truck

Bruce Leasing will not be able to supply the new truck for the wastewater plant, that it had been the low bidder in a tender in June. On September 4th the company advised they could not fill the tender. Staff went back to the bids and awarded the tender to Hollis Ford in the amount of \$25,531. Hollis' original bid was \$24,769, which was approximately \$800 higher than Bruce Leasing Submission, however, Hollis' price increased by \$762 to \$25,331, but it was still lower than Pye's bid of \$27,022.

Solicitor Dennis James, asked if Bruce Leasing had been requested to pay the price differential. Staff had not considered, that as a request, but will discuss with the solicitor for future action.

Paul Smith provided an update on the Fundy Discovery Site. The components of the update included a new public washroom, dyke trail, natural playground, service extensions and signage. Excessively high tenders for the washrooms and the water service extension prompted staff to recommend these projects be contracted in-house. With three of the five projects completed, staff reported:

**Public Washroom:** Approved Capital Budget: \$241,326; Actual Project Cost: \$193,697; Surplus: \$47,629. Tender Price: \$345,000; Net "Contract-Out" Savings: \$151,303

**Water Service Extension:** Approved Capital Budget: \$125,000; Actual Project Cost: \$26,319; Surplus: \$96,681; Tender Price: \$149,552; Net ("Contract-Out") Savings: \$123,233

**Pylon Sign:** Approved Capital Budget: \$10,000; Actual Project Cost: \$10,339; Net Overrun: (\$339)

Staff have also pursued several funding opportunities that

(6). \$25,000 (tentative) from the Trans Canada Trail Foundation for trail head improvements and site amenities. (7). \$10,000 (tentative) from the Community Accessibility Program for site amenities and pathway surfacing to improve accessibility for individuals with mobility challenges.

Collectively, these account for \$237,000 of additional but unexpected funding that will serve to enhance features at the Site while enabling Council to redirect future capital funding needs to other components.

Planning is underway for successive phases (approved by Joint Council in March 2017) which will include an outdoor amphitheatre, tidal bore viewing areas, interpretation, additional landscaping and roadway / parking improvements.




