


*In order for each resident to have access to high-speed internet, the county should allocate additional tax money, if required, to support the companies involved with installing this service.*

**Big Moon Canada Joins FORCE**

The province used an independent and competitive process to fill the vacant berth at the Fundy Ocean Research Centre for Energy (FORCE) in Nova Scotia's Bay of Fundy. Big Moon Canada Corporation (Big Moon) has been selected by the independent procurement administrator as the successful applicant to fill berth D at the centre. As part of the agreement, the company will also remove the Cape Sharp turbine.

With authority from the minister, the procurement administrator has granted the

company a Marine Renewable-Electricity licence and a power purchase agreement. The company has provided a security deposit of \$4.5 million in relation to their commitment to the retrieval of the Cape Sharp turbine.

The Cape Sharp turbine is non-operational and does not present a risk to marine life or the environment. Big Moon Canada must submit and have a retrieval plan approved by the province and has until Dec. 31, 2024 to raise the turbine.

**What level of priority do you place on marketing the county as a desirable place to live and invest in attracting new residents, who might start or purchase an existing business?**

*That is the catch 22 question! There is really no way of deciding who will come here, what their goals are, or what would attract new residents, for example, a person from anywhere to locate here and start a business. The best we can do is to support our local immigration groups, church sponsors, local service clubs, and other community-based/government sponsored agencies in their work on immigration.*

**Colchester has a new hospital, RECC centre, Dal Ag Campus, Nova Scotia Community College, excellent geographical location and many other assets all within two hours drive to other major urban centres and almost one million consumers. What does the municipality need to focus on to be the fastest growing municipality in the province?**

*Quite simply, build on what we have in these modern facilities, our location as the HUB, and supporting initiatives like the Truro Downtown Partnership, and more... Linking websites, which is being done, and co-promoting what we have to offer through our community partners is a key to shared future growth and development. In addition to our modern facilities we have a rail link, highway links, and are just 40 minutes from an international airport. All critical points that require us to govern in ensuring these assets are maintained and serve us well.*

**What approach to municipal governance will you take to obtain the important things in your district?**

*As you can see from my campaign logo 'Caring for Our Community and County', my focus will be on small things in terms of service to our District and taxpayers, and on big things in terms of projects requiring significant investments across the District and County.*

**What is most needed in your district?**

Nature, trails – summer and winter, skiing – downhill and cross-country, pony clubs, golf courses, swimming pools, ice rinks, curling clubs, atv & snowmobile clubs, running and bicycling groups, card clubs, post-secondary education, schools, rural communities, hospitals and more... **What professional or personal experience do you bring to the council table?**

*I have been a life-long resident of Salmon River and have seen our local area grow in significant ways over my years.
