NOVA SCOTIA WINES RECEIVE AWARD FOR EXCELLENCE

Four wines received the 2021 Lieutenant-Governor's Award for Excellence in Nova Scotia Wines at a ceremony at Government House in Halifax on September 9. The following wines, listed in alphabetical order by vineyard, were selected as the best among the wines submitted: 2015 L'Acadie, Avondale Sky Winery, Newport; 2014 Prestige Brut Estate, L'Acadie Vineyards, Wolfville; 2010 Fortified Castel, Mercator Vineyards, Wolfville and NV Passito Muscat, Mercator Vineyards, Wolfville.

"Nova Scotia's winemakers are producing exceptional wines, and many are successfully competing on the national and international level," said Lt.-Gov. Arthur J. LeBlanc. "This success reflects the passion and expertise of our wineries and winemakers, and they can be very proud of how they have contributed to this province's wine and tourism industries. I thank and congratulate all wineries who submitted wines for this year's award."

Now in its eighth year, the award is administered in conjunction with Wine Growers Nova Scotia and Taste of Nova Scotia.

BURRILL: HOUSTON MUST EXTEND RENT CONTROL

NDP Leader Gary Burrill is calling on Premier Tim Houston to make a clear commitment to extending rent control. Houston made comments during the campaign that he is against rent control, which were echoed by Housing Minister John Lohr late last week.

"People are incredibly worried about how much their rent will go up when the temporary rent controls are lifted. Already some people are receiving notices that their rent will go up by hundreds of dollars," said Burrill. "There is a simple solution; continue with rent control to prevent massive rent hikes when the state of emergency is lifted."

All parties committed to building more affordable housing during the most recent election, but expanding the supply of affordable housing will take years to accomplish.

"Today's question is whether or not thousands of families will be able to afford their rent in a matter of weeks, not whether or not some developers will decide to build some new housing units some years in the future. The Conservatives need to act immediately to help families keep their homes," said Burrill.

TRUTH & RECONCILIATION DAY TO BE RECOGNIZED ANNUALLY

Nova Scotia will annually recognize Sept. 30 as Truth and Reconciliation Day beginning in 2021. Provincial government offices, public schools and regulated child care will be closed. Businesses will have the choice, as they do on other occasions, to remain open.

"We are taking this step to recognize the importance of honouring First Nations, Inuit and Métis residential school survivors and their families and communities," said Premier Tim Houston. "We encourage all Nova Scotians, whether you are working or in school, to make time on September 30 for important discussions about Canada's history of residential schools."
