Looking at the bottom line, when considering revenues, and expenditures for the 10 months ending January 31, 2017, and comparing Actual YTD Vs YTD Budget, the municipality has spent \$1,001,110 less than its Year to Date (YTD) budget.

At the March 15th meeting of Cumberland County Council public hearings and demolition orders were approved for three properties located at: 26 Wolsey Street Springhill; 47 Richards Road, River Hebert and 341 Highway 6, East Amherst. Council also gave 1st reading to repeal dog bylaw in Springhill and Parrsboro with

the intent at the end of the by-law change policy to adopt a county wide by-law to permit canine by-law officer to have standard by-law across the county.

Tax Reduction and Exemption Policy, granted notice at March 1st meeting brought back to council for March 15th. Tax exemptions for the whole amount were given to the following properties. In this report we have listed only those in the coverage area of the South Cumberland News.

They are as follows: Spencer's Island Community Association for lighthouse # 186 and land and lot at Spencer's Island; Greville Bay

Ship Building Museum Society, for building and lot at Port Greville; Fossil Display Centre, Joggins; Diligent river Recreation Committee for building and lot; Advocate District Development Ass for campground, building and lot; Fraserville Community Hall Assn for community hall; Southampton and Area Ball Association for land; Anne Murray Centre Society for land and museum; FORCE for

visitor centre, land; Lions Club of Parrsboro, land on King Street, 210 King Street for land and arena and The Ships Company Theatre Society for theatre.

Partial exemptions were given to the following: Wentworth Ski Race Club for land; Cumberland Snowmobile Club for land; Masonic Lodge No 17, Parrsboro for residential and commercial mix property and Parrsboro Band Association for land and Fellowship Hall.
