
We began council Wednesday, February 1st at 5 pm in camera with 5 items covered and 2 of those moved to public council. This was followed by a short nomination committee meeting where a couple of councilors changed committee's due to conflict and we nominated two citizen's appointments for public council.

We began public council at 6:30 pm with a minute of silence for the tragedy in Quebec. The first item was an update from our EMO coordinator, Mike Johnson, on the ice storm in New Brunswick and the support from Cumberland county. We provided 16 genera-

tors for their use.

Next was a presentation from Denise Corey, head librarian for Cumberland County. She told it like it is and they are in financial trouble. From her presentation it appears the province is not providing the necessary funds to help the operation. They either need to cut more programs, staff hours or close a branch of which there are 7 within the county.

We have increased funding year after year in support as we see the need and the positive use in our communities. We need the province to step up so please, when you see our MLA'S out and about, tell them we need provincial support for our libraries.

This was followed by a short presentation on the Cumberland Joint Service Municipal Agreement (CJSMA)

budget. Later we passed the budget by motion. There was 1 public hearing for dangerous and unsightly, with a property in Parrsboro. Motion approved for removal.

Pugwash water proposed expansion was next with approval given pending provincial and federal, agreement. Motion passed. A policing review was approved for the municipality to ensure we are receiving the correct services for our citizens. A motion to approve first reading of a bylaw to repeal the former Town of Parrsboro's tax exemption bylaw was approved. A new policy to coincide with the rest of the municipality will replace it in the near future.

If you are confused now, I did my job! A motion to support

the naming of a bridge in Tignish the "Gillian Lawrence Memorial Bridge" was approved. A motion to approve the mandate for the Divestiture of surplus property committee was passed by motion. This was a follow up to a November meeting.

A motion was approved to have transportation study speed limits in and around Parrsboro now that it is a part of the municipality and the town limits are no longer there.

We approved the following topics be sent to UNSM for consideration at the upcoming

spring workshop per their request: toll highways; regional solid waste/extended producer responsibility(EPR) and off road vehicle use of highway shoulders. Motion passed.

Information items were an upcoming joint council meeting on February 22nd in Amherst; canine control/bylaw enforcement officer report, as well as, a memo outlining the 6 strategic priorities as set by the previous council. Next council February 15th.

## Tidal Turbine Still Being Commissioned

Last week with linemen working on power lines in the Parrsboro area, it was suggested the Tidal Energy turbine which had been deployed in Minas Channel in early November was not connected to Nova Scotia Power electricity grid. Immediately I contacted Sarah Dawson, Tidal Energy community liaison spokesperson, asking for an update: "how much power has been generated from the one deployed turbine, since Michel Samson

threw the switch to upload power directly to the grid?"

Her response was: "You can see daily information about the entire energy mix in Nova Scotia at any given time on the Nova Scotia Power website: <http://www.nspower.ca/to-dayspower>. (Practically speaking, in-stream tidal output is too small for its own dedicated line so it is combined with hydro and the Annapolis Tidal plant on the graph.)

Each CST turbine is capable of producing

about 2MW of tidal power and when the entire demonstration project is commissioned (2x 2MW turbines) the array will produce enough tidal energy to power the equivalent of about 1,000 homes in Nova Scotia. That represents 6,000 tonnes in GHG CO2 emission reductions—which is like taking 1,000 cars off the road annually or displacing the need to burn 2,000 tonnes of coal.

In my query to her, I asked: "Has the turbine been performing to expectation?" To which she responded: "Cape Sharp Tidal is still the commissioning phase and the turbine has been performing as expected. Operation teams are testing the turbine, making software adjustments, and production is being gradually

increased over time while being testing during different tidal cycles.

While the technology is still in its early demonstration stage, the deployment indeed represents exciting progress in the development of innovative, new renewable energy and as Nova Scotia continues to lead the country in carbon reduction, the Bay of Fundy has potential to play an important role in clean energy generation".

When the turbine was deployed some media reports stated, the Minas Channel turbine was the first turbine in the world to be connected directly to an electrical grid. She provided clarification stating, "Ours isn't the world's first in-stream tidal turbine to be grid-connected, but it is the first in Canada".
