

Services Available at SCCCC

To explain the importance of SCCCC to the Parrsboro area, I researched by checking the Department of Health and Wellness website to find the following information is listed regarding the Outpatient / Emergency Department at SCCCC facility in Parrsboro: The centre provides 24 hour emergency services as well as outpatient/consultative clinics. All patients utilizing the emergency services will be triaged (evaluated). There are four major categories of triage - emergency/life threatening, urgent, less urgent and not urgent. The evaluation of an individual's condition by the nurse will determine how quickly they will be treated. Everyone is reminded that while every effort is made to ensure treatment is received in a timely manner, patients will be seen by a doctor in order of need. The arrival by an Emergency Health Services ambulance of a seriously ill person can also have an impact on the length of wait for walk-in patients.

Reference to Collaborative Practice (Nurse Practitioner) is as follows: The community of Parrsboro is fortunate to have access to the services of a nurse practitioner who works in a collaborative practice with two local family physicians. The establishment of this primary health care delivery model has enhanced the services available in the community while freeing up physician time to treat more acute medical needs. One of the primary objectives of a collaborative practice is improving accessibility to primary care providers.

A nurse practitioner works collaboratively with a family physician to provide a range of primary care services including diagnosis, treatment and monitoring of commonly encountered health problems and injuries as well as monitoring stable chronic health problems. A focus on health promotion, injury and illness prevention, community development and advocacy allows nurse practitioners to develop a special rapport with their patients and the community-at-large.

The South Cumberland Community Care Centre offers a number of clinics and services on an out-patient basis. These include:

SCCEC Closed 11 Days

Closures continue to plague the South Cumberland Collaborative Emergency Centre (SCCEC) in Parrsboro. The facility was closed for a total of 132 hours -11 day daytime closures from August 4th to August 21. The overnight coverage (8:30 p.m. to 8:30 a.m.) provided by the paramedic/registered nurse/over-sight physician team will be available as usual.

The twelve hour closures are necessary because no physician coverage is available. The department will be closed from 8:30 am to 8:30 pm as follows: August 4, 5, 6, 7, 11, 12, 13, 14, 18, 19 & 21. Each of the dates were Tuesday, Wednesday, Thursday and Friday daytimes, with the exception of Thursday, August 20th, which the centre was open.

The public is reminded that in all circumstances, those experiencing a medical emergency should always call 911. General health concerns can also be directed to HealthLink 811 where advice and information are available around the clock. Simply dial 811 to speak with a registered nurse.


