## Little Dyke Residents Not Backing Down

People living near Little Dyke Lake, Colchester County are contemplating an appeal and a judicial review of Environment Minister Iain Rankin's approval of a giant Irving-owned OSCO gravel pit within sight of their shoreline.

On August 24, 2017 the Minister of Environment announced he has approved the undertaking in accordance with Section 13(1)b of the Environmental Assessment Regulations, pursuant to Part IV of the Environment Act. The undertaking has been approved subject to a number of conditions which includes: development and submission of a complaint resolution program to address public concerns; appoint a contact person to handle complaints from the public and form a Community Liaison Committee. Additional conditions include developing and

implementing a Mi'kmaq Communications Plan which will include a process to communicate project details and to seek input from the Mi'kmaq community.

The Glenholme-Little Dyke Residents Association is currently consulting with its lawyers to review its options. Spokesperson Ian MacFadden says the group's members are firmly committed to seeing this through. "We believe the approval process is flawed, and that mistakes have been made in the review of Irving-OSCO's proposal," he says. "The province has not followed its own regulations in arriving at its decision last week. Our legal team advises us that we're on firm legal ground as we contemplate a judicial review."

The Ministerial approval came down on August 24th with some restrictions on noise and water monitoring for the

giant gravel pit, but nothing to limit its hours of operation, which are planned for up to 22 hours a day. Other restrictions include distances from watercourses and wetlands; vegetation removal, water surface monitoring, distances for excavation above the maximum water table.

A groundwater monitoring program including location of monitoring wells to determine impacts on groundwater levels and quality. Any flora and fauna to be removed must be done outside normal bird breeding season April 15 - September 1. OSCO must implement an air quality and or dust monitoring program along with a noise management plan which is to be monitored on an ongoing basis.

Work at the site must cease immediately upon discovery of an archaeological site or if artifacts are unearthed.

Conditions laid out in the company's prior approval (in 2007) were not consistently monitored or enforced by the provincial government," says MacFadden. "We've looked for accountability on the part of the government, and we just haven't been able to find it."

Irving-owned OSCO Aggregates is planning a 75-acre gravel operation that would extract more than one-million tonnes of material within 500 meters of Little Dyke Lake.

"We submitted a lengthy document to the environment Department detailing the Association's many concerns with the project, including ongoing compliance infractions with existing operations, that otherwise would have gone unnoticed," says MacFadden. "We have no confidence that the government can be relied on to consistently enforce these latest conditions that Minister Rankin has mandated".
