
One Call Can Save a lot of Grief

Before I begin, just a reminder that if you are planning a building or renovation call the municipality toll free at 1-888-756-6262 to find out if you require a permit. One phone call can save a lot of grief.

We began council on July 25th at 5 pm in camera with five items covered.

After short break public council began with three presentations. First the Parrsboro playground committee presented a proposal for a playground near service center. It was well presented with great information and a good project to support.

Next we had a presentation from Lands and Forests (DNR) regarding the bear

population and their search for food. It appears the June frost affected them too. It was suggested if you can freeze your compost until garbage day this will help if you are having a problem. A spring bear hunt could be in the cards for near future.

Third presentation was on the provincial legislation for coastal protection that is being worked on which will define a coastal protection zone and regulate activities within the zone and create provisions for monitoring and compliance. To fill out an online survey visit novascotia.ca/coast or call 902-424-2547 for paper copy.

A motion to adopt the property assessed clean energy program was approved as well as purchase of three properties in the Pugwash Wellfield Protection Zone. The sexual harassment policy, safety light policy, streetlight policy, and work clothing policy will all be considered for adoption at the September 5 council session.

Staff will also present information on a new flag policy at same meeting. A request for tax exemption for the youth hostel in Wentworth was discussed and the policy will be amended for approval. The grant to NSCC foundation was

approved as well as 4 others.

A joint council meeting has been tentatively scheduled for September 17 at Joggins Fossil Cliffs. A planting program for the NS Border committee was approved. The quarterly financial report was discussed and contained great information.

Two community members were approved to sit on the East Cumberland Lodge Board. Approval for staff to enter into a one year lease for use of lower level of the Miners Hall, Springhill was also approved.

The councillor's package also included information items on: libraries report; Cape D'Or replica lighthouse disposal; Cumberland business connector-annual report; update on Cannabis work; curbside collection; Cumberland Y AGM update; project facilitators report; demolition report; canine control/by-law officers report; code of conduct update; CAO/CEO forum report; audit committee report and learn to lead partnership series.

Thank you letters were also in our package. It was a long council session with a lot of information. Question: are you planning a renovation? Call your councilor!

Studio B, 206 Main Street. Heather van der Breggen, from Weyburn Saskatchewan, has the sixth residency from September 14 to September 29 at Studio C, 83 Main Street.

Parrsboro Creative residences range from one to three weeks, and each artist receives free accommodation, studio space on Main Street, and a weekly honorarium. "We do everything we can to make these people feel at home, and to provide an environment that allows them to explore and take their artistry to the next level", says Parrsboro Creative Board Chair Michael Fuller. Cape Sharp Leaves Trail of Debt

Million and got a seat on the Board of Directors for a 2.2% stake in OpenHydro. Emera also obtained a 20% stake in Cape Sharp Tidal, while OpenHydro owned the remaining 80%. Following the July 25th Insolvency filing, an Emera spokesperson stated Emera has resigned its seat on OpenHydro's board in March.

The tally of who in Nova Scotia is owed what amount has been hard to confirm as many companies fear going public may jeopardize receiving an early payment. Many Parrsboro businesses who has supplied accommodations and food services were shocked to learn their guests, who had been working on the turbine's deployment the week previous were out of a job and they had not been paid.

Fishers in the Bay of Fundy, who had suffered loss of gear, or were supposed be compensated for movement of their gear were left wondering if they would receive payment.

Here's a partial list of debtors:

Mark Taylor, a lobster fisherman from Hall's Harbour is reported to have lost 99 traps, and movement of his gear in 2018 has cost him in excess of \$75,000.

Jay Grant, owner of

Riverview Cottages, Parrsboro, was able to get 50% deposit on the booking for 9 cottages, but was still left owing \$5,311.20 when occupants of the cottages left quickly.

The bookings were for 2 and half weeks in July, the busiest time of the year.

Most of Parrsboro's fixed roof accommodations were booked to capacity by the Irish company and its contractors.

RMI Marine Ltd. Eastern Passage is owed \$447,719.14 for diving services and providing a vessel for the prep and installation of the two-megawatt tidal turbine.

Another marine services company in the Annapolis Valley is reported to be owed in excess of \$150,000 for its services.

Meanwhile, the 16 metre diameter turbine is sitting on the floor of Minas Channel spinning freely without any environmental monitoring. As of August 15th it was one week beyond the allowable time frame without monitoring.

Fishers and others are pressuring to have DFO and other governments either provide monitoring or pull the rig out of the water. There is speculation it's a waiting game hoping Grant Thornton, the court appointed receiver is hoping for a quick sale of the turbine.
