On August 16th the Nova Scotia Health Authority

advised the public the emergency department at the South Cumberland Collaborative Emergency Centre in Parrsboro would be closed as follows: Sunday, August 19 from 8:30 a.m. to 8:30 p.m.; Monday, August 20 from 8:30 a.m. to 8:30 p.m.; Tuesday, August 21 from 8:30 a.m. to 8:30 p.m.; Wednesday, August 22 from 8:30 a.m. to 8:30 p.m. and Thursday, August 23 from 8:30 a.m. to 8:30 p.m.

These closures were necessary because no physician coverage is available. The department would be open during overnight hours (8:30 p.m. to 8:30 a.m.) with coverage provided by the paramedic/registered nurse/over-sight physician team.

Cape Sharp Leaves Trail of Debt

The demise of OpenHydro following the July 25th petition in Dublin, Ireland by Naval Energie Group claiming Insolvency should not come as a total surprise. In an article "2018 Predictions from a Fisherman" published on Page 4 of the February 2018 Shoreline

Journal, Darren Porter the vocal weir fisherman from Bramber predicted the collapse.

In the article he wrote: "I think Open Hydro is done, or near done. 70 people layed off worldwide; their turbines pulled out of the water, in different counties. Word is their Technology is not working out.

It produces its own electric field which creates galvanic reactions (promoting corrosion)".

In the same article, Porter wrote, "Annapolis Royal Tidal Power Generating Station may fall as it's living proof environmental effects of this tidal industry will not be addressed regardless of how bad these

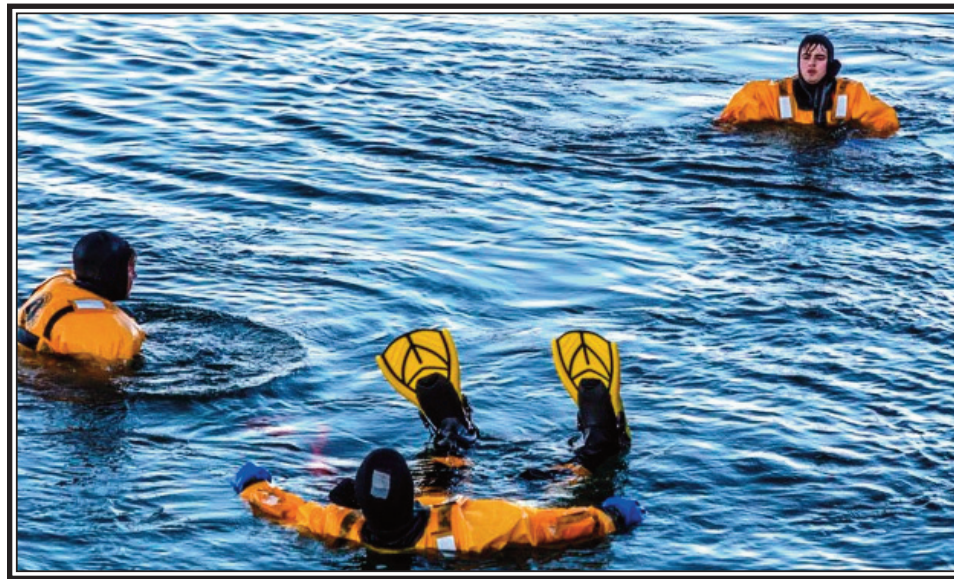
effects are". The Annapolis Royal facility has not fallen but it is now under the microscope by DFO.

The July 25th filing by Naval Energie Group, OpenHydro's largest shareholder and creditor for Insolvency has left a trail of unpaid invoices estimated to be almost a million dollars to several Nova Scotia businesses who used their expertise to achieve a successful deployment of Cape Sharp's turbine into the Minas Channel the week of July 20th.

Many who are owed money are upset at the timing of Insolvency filings in Dublin Court. The companies worked hard to achieve success with deployment completed on July 22nd, and the turbine connected to the sub-sea electrical grid on July 24th only to have the company declared insolvent less than 48 hours later.

According to court documents OpenHydro's Nova Scotia's entity, Cape Sharp Tidal, which owns the turbine had \$12-Million in cash which was enough to keep it operational until August 20th. Cape Sharp required \$1.7-Million every week to survive. The company was expected to lose a further \$219-Million by 2026.

In 2008 Emera paid \$15-

The Parrsboro Creative Artist-in-Residence program has also taken a quantum leap forward. "There were four times as many applications this year," says Executive Director Robert More, "and the quality of the submissions was impressive. Every artist who applied is highly talented, and we received submissions from across Canada this year, a very good sign that Parrsboro's reputation is continuing to grow on a much bigger scale".

The first guest artist is Ann Willis - August 15 to September 5. Ann is from Lake Country, British Columbia. A member of the Federation of Canadian Artists, Ann's bold impressionistic style has won

numerous awards in many FCA shows and Plein Air Festivals. An unabashed enthusiast, within minutes of her arrival Ann was swept away by the spectacular beauty of this area and finished her first painting by noon on her second day! There will be an exhibition of her new work opening at 2:00 pm on Sunday September 2 at Parrsboro Artist-In-Residence Studio A, 206 Main Street.

Following Ann Willis, there are five more artists-in-residence for this year. Bill Rogers from Antigonish Nova Scotia, one of the best Plein Air artists in North America, will be on site August 30 to September 5 at Studio C, 83 Main Street. Following Bill, is Eileen Henneman from Almonte Ontario, September 8-23, also at 83 Main Street.

The fourth guest artist is Ken DeWaard from Hope, Maine, September 8-16. His working space will be Studio B at 206 Main Street. Susan Paterson, our fifth artist, from Dartmouth Nova Scotia is here September 16 to September 28, also working at

Tidal Runner Returned to Eastern Passage

RMI Marine guided "The Tidal Runner" onto a Ruggles Towing float on for transport to Eastern passage. The Tidal Runner had assisted with the deployment of Cape Sharp's Tidal turbine the previous week. It is reported the company is owed in excess of \$750,000. They have taken legal action and got the sheriff to arrest the barge, "Scotia Tide". The barge which was built in Pictou was specifically designed to deploy and remove Cape Sharpe's Tidal turbines, is now in Saint John, NB.

Cape Sharpe was placed in receivership by its largest shareholder and investor by Naval Energie Group in court proceedings in Dublin Ireland, two days after the turbine was deployed and connected to the electrical grid in its berth at the FORCE site.
